ORDER:

During the Budget Speech delivered by the Hon'ble Finance Minister on 22.7.2006, in the Tamil Nadu Legislative Assembly , it was announced that a separate Welfare Board for Goldsmiths will be established. Tamil Nadu Potters (Kulala) Federation, Chennai has also requested the Government to form Tamil Nadu Pottery Workers Welfare Board separately. Accordingly, the Commissioner of Labour has been requested to send necessary proposals to Government in this regard.

2. The Commissioner of Labour, in his letters first and second read above, has sent proposals to Government for the formation of separate Welfare Boards for Goldsmiths and Pottery workers.

3.After careful examination, the Government direct that the following 2 Welfare Boards be established separately and be notified in the Tamil Nadu Government Gazette under Section 6 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982, as appended to this order:-

- 1) The Tamil Nadu Goldsmiths Welfare Board.

- 2) The Tamil Nadu Pottery Workers Welfare Board
(தமிழ்நாடு மண்பாண்டத் தொழிலாளர் நல வாரியம்)

Orders regarding the nomination of members to each of the above two Boards will be issued separately.

4.The Government approve the Tamil Nadu Goldsmiths Social Security and Welfare Scheme 2006 and Tamil Nadu Pottery Workers Social Security and Welfare Scheme 2006. Orders notifying the above said Welfare Schemes will be issued separately.

5.The appended notification regarding the formation of 2 Welfare Boards shall be published in the extraordinary issue of the Tamil Nadu Government Gazette dated 1st September 2006, in English.
