ORDER:

In the letters read above, the Director of Medical and Rural Health Services (ESI) has sent the proposals based on the Hon'ble Minister for Labour Welfare's Floor Announcement, 2008-2009 for implementation of Employees State Insurance Scheme to Cumbam Municipality, Chinnamanur and Uthamapalayam Municipality in Theni District, Muthalapuram and Pudukkottai area in Tuticorin District, Nagercoil Pheriparals and Kanniyakumari Town in Kanniyakumari District by attachment with the existing Employees State Insurance Dispensaries.

2. After careful examination, the Government accept the proposals of the Director of Medical and Rural Health Services (ESI) and sanction the implementation of Employees State Insurance Scheme to Cumbam Municipality, Chinnamanur and Uthamapalayam Municipality in Theni District, Muthalapuram and Pudukkottai area in Tuticorin District, Nagercoil Pheriparals and Kanniyakumari Town in Kanniyakumari District by attachment with the existing Employees State Insurance Dispensaries as follows:-

3. Sanction is also accorded for incurring recurring expenditure of Rs.13,18,400/- (Rupees Thirteen lakhs eighteen thousand and four hundred only) towards provision of medicine to 6592 workers and their family members.

4. The expenditure will be initially incurred by the State Government and fully reimbursed by the Employees State Insurance Corporation for the first three years period, from the date of implementation of Employees State Insurance Scheme in the above areas and thereafter, the expenditure shall be shared between the employees State Insurance Corporation and the State Government in the agreed ration of 7:1.

5. The expenditure shall be debited to the following head of account:-

“2210 Medical and Public Health - 01 Urban Health Services - Allopathy-102 Employees State Insurance Schemes. I-Non Plan AG - Expenditure on ESI Scheme both Insured Persons and their families” 66-Medicine.

6. The expenditure sanctioned in Para 3 constituted an item of New Instrument of Service. The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance drawn from contingency fund. Orders regarding which will be issued separately in Finance (B.G.I.) Department. The Director of Medical and Rural Health Services (ESI), Chennai, is requested to apply in duplicate for sanctioning contingency fund in the prescribed proforma along with the copy of this order to Government in Finance (B.G.I.) department and to send necessary note for First Supplementary Estimate 2008-2009 for inclusion of this expenditure at the appropriate time.

7. The formal Notification under Section 1 (3) of the Employees State Insurance Act 1948, fixing the date from which the medical facilities shall be extended to the insured persons and their families in the above areas will be issued by the Central Government. The Director of Medical and Rural Health Services (ESI) shall suggest immediately a suitable date for the extension of the Employees State Insurance Scheme to the above areas after making all the medical arrangements in the said dispensaries in consultation with the Regional Director, Employees State Insurance Corporation, Chennai.

8. This order issues with the concurrence of the Finance Department vide its U.O.No.108/JS (JV)/Labour and Employment Department/2008, dated 29.7.2008 and with ASL No. 488 (Four hundred and eighty eight.)
