In the Government letter second and third cited 8(5+3) supernumerary posts and 57 (34+23) supernumerary posts have been allotted to Animal Husbandry and Fisheries Department and Home Department respectively.

- 2. The Animal Husbandry and Fisheries Department has requested to sanction 8 supernumerary posts additionally for that Department so that the above posts may be reallotted to Directorate of Fisheries in order to provide employment assistance in the cadre of posts Sweeper, Gardener for the legal heirs of deceased Government servants who are waiting for the same.
- 3. Out of the 57 supernumerary posts sanctioned to Home Department, only 3 supernumerary posts have been allotted to Home (Pro.II) Department. The Home

- (Pr.II) Department has requested to allot 7 more supernumerary posts in order to meet the requests of legal heirs of deceased Government servants for providing compassionate appointment to them.
- 4. In the U.O.Notes 4th and 5th cited, Municipal Administration and Water Supply Department and Information and Tourism Department have surrendered 7 and 13 supernumerary posts respectively sanctioned in the references second and third cited, Besides, Co-operation, Food and Consumer Protection also has surrendered one supernumerary post in the letter 6th cited.
- 5. For the reasons stated in para 2 and 3 above, the Government after careful examination have decided to accept the proposals of Animal Husbandry and Fisheries Department and Home (Pr.II) Department and accordingly, Out of the 21 surrendered supernumerary posts mentioned in para 4 above, the Government reallot 7 supernumerary posts to Animal Husbandry and Fisheries Department and 7 supernumerary posts to Home (Pr.II) Department in addition to the supernumerary posts already allotted to the above Departments in references 2nd and 3rd cited.
- 6. Attention is also invited to para 12 of the Government order 1st cited wherein it has been ordered that the supernumerary posts allotted to each Department should be used as a cushion to clear the backlog and the incumbents of the supernumerary posts should be shifted to regular vacancies as and when vacancy arises and the vacant post of supernumerary posts should be utilized again for providing employment to the next candidate in the waiting list, if there is any of the unutilized posts should be surrendered to the Government for re-allocation to other needy Departments.
