ORDER:

In the Government Orders read above Government withdrew the recognition of the following Government Employees Unions/Associations and Teachers Unions/Associations for having participated in the illegal strike in violation of the provisions of Government Servants' Conduct Rules and the Tamil Nadu Essential Services Maintenance Act 2002 during July 2003 under Rule 6 of the Tamil Nadu Government Servants' Recognition of Service Association Rules, 1974 with effect from the date of issue of order:-

- 2. The various Government Employees Unions/Associations have requested the Hon'ble Chief Minister that the recognition of the 37 employees unions which had been withdrawn following the strike in July 2003 be restored.
- 3. It is necessary for Employees Unions and Teachers associations to function responsibly in close co-operation with the Government so that services are rendered effectively and efficiently to the people. Never for a moment should Employees Unions and Teachers Associations forget this responsibility. There may be grievances and requests, but Employees Unions and Associations should always realize that the primary purpose of the Government itself is to reach out to the poor and needy and provide a better life to them.
- 4. In view of the assurance made by the Employees Unions and Associations of Teachers, that they will discharge their responsibility with care and diligence in close co-operation with the Government and also keeping in mind the spirit of good will and co-operation extended by Government Employees and Teachers Associations, it has been decided to restore the status-quo ante prior to the strike in July-2003. Hon'ble Chief Minister has announced that all the 37 Employees Unions and Teachers Associations whose recognition was withdrawn following the strike will again be granted recognition with the expectation that they will carry out their functions in responsible manner and also inculcate among their members the mission of improved service to the people.
- 5. Accordingly, Government direct that the recognition of the 27 Unions/ Associations cited in para 1 above be restored from 20-10-2004. In respect of other 10 Unions / Associations, separate orders will be issued by Department of School Education.
