Sub :Tamil Nadu Government Servants's Conduct Rules, 1973 – Grant of "No Objection Certificate" under rule 24A of Tamil Nadu Government Servants Conduct Rules – Instructions – Issued.

Under rule 24A of Tamil Nadu Government Servants Conduct Rules "No Objection Certificate" is granted to Government Servants to apply for passport to visit foreign countries. While applying for such No Objection Certificate", information regarding the purpose of visit, the duration of stay, and the names of countries proposed to be visited will have to be furnished by the Government servants. The Government after considering the material, grant "No Objection Certificate" to Government servants subject to certain conditions regarding taking up any appointment, tendering resignation, execution of bonds/etc. The Government also may point out that though

the pendency of disciplinary action against the Government servant is not a legal bar before granting "No Objection Certificate", yet this is being ensured in the interests of administration and also to avoid any embarrassment to Government at a later date.

- 2. I am to state that while recommending "No Objection Certificate" to Government servants for grant of passport or for renewal of passport or for undertaking any trip abroad, the following guidelines may be followed:
 - 1. (i) No binding period to serve this Government need be prescribed for those who undertake foreign tours as tourists or to visit relatives and to visit holy places.
 - 2. (ii) The bond may be executed by Government servants who go abroad at the time of applying for leave only and not at the time of applying for No Objection Certificate for applying for passport etc.
 - 3. (iii) It should be ensured that no disciplinary action is pending against the Government servants concerned.
- 3. I am directed to request you to bring the above instructions to the notice of the subordinates under your administrative control for compliance in future.
