Tamil Nadu Government Servants Conduct Rules, 1973—Rule 3 (A) (2) – relating to prohibition of acceptance and giving of dowry by Government servants – Declaration, Format – Prescribed.

## ORDER:

According to rule 3A of the Tamil Nadu Government Servants Conduct Rules, 1973, no Government servant shall give or take, abet the giving or taking of dowry or demand directly or indirectly from the parents or guardian of a bride or bridegroom, as the case may be, any dowry.

- 2. In the G.O read above, the above rule was amended to the effect that every Government Servant shall after marriage or when he celebrates the marriage of his children, furnish to the Head of Department, a declaration that he has not taken any dowry. Where the Government Servant gets married, the declaration shall be signed by the Government Servant, the wife or husband, as the case may be, of the Government Servant and their parents or guardian. Where the son or daughter of the Government Servant gets married, the declaration shall be signed by the parties to the marriage and their parents or guardian which shall include the Government Servant also.
- 3. The Government have now decided to amend rule 3A of the Tamil Nadu Government Servants Conduct Rules, 1973 and direct that every Government Servant shall furnish a declaration to the above effect to the Heads of Department in the Form in Schedule IV now appended to the above said rule.
- 4. The following Notification shall be published in the Tamil Nadu Government Gazette.

#### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Government Servants Conduct Rules, 1973.

2. The amendments hereby made shall come into force on the 29th September 2009.

## <u>AMENDMENT</u>

In the said Rules.

- (a) in rule 3 A, in sub-rule (2), after the expression "Every Government Servant shall after marriage or when he celebrates the marriage of his children, furnish to the Head of Department, a declaration", the expression "in the Form in Schedule IV appended to these rules" shall be added;
  - (b) after Schedule III, the following Schedule shall be added, namely:-
