

Tamil Nadu Secretariat Service – Assistant Section Officer – Prescription of minimum service of one year – For Assistant Promotion from Graduate Typists – Special Rules – Amendment – Issued.

G.O. Ms.No.175, Personnel and Administrative Reforms (U) Department dated 24.11.2005.

ORDER:

In the Government Order read above a minimum period of one year has been prescribed for an Assistant, promoted from the category of Graduate Typist, for promotion as Assistant Section Officer. It was indicated therein necessary amendment to Special Rules for Tamil Nadu Secretariat Service will be issued separately.

2. The following Notification will be published in the <u>Tamil Nadu</u> Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Secretariat Service (Section 29 in Volume III of the Tamil Nadu Service Manual, 1970).

2. The amendment hereby made shall be deemed to have come into force on the 24th November 2005.

<u>AMENDMENT</u>

In the said Rules, in rule 14, in the Table, to item (ii) (b) in column (3), against the corresponding entry "Promotion or transfer" in column (2), against "Category – 1 Assistant Section Officers in the Departments of Secretariat

other than the Law Department and the Governor's Secretariat", in column (1) thereof the following proviso shall be added after the third proviso namely: -

> "Provided also that graduates promoted to the category of Assistant from the category of Typist must have put in service for a period of not less than one year in the category of Assistant"
