ORDER:

In the Government Order first read above, orders have been issued exempting the Destitute Widows from paying the examination fees for appearing in the examinations to be conducted by the Tamil Nadu Public Service Commission for recruitment to various posts in the State.

2. Consequent on the above orders, the following Notification will be published in the Tamil Nadu Government Gazette.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the General Rules in Part - II of the Tamil Nadu State and Subordinate Services Rules (Volume-I of the Tamil Nadu Services Manual, 1987).

2. The amendment hereby made shall be deemed to have come into force on the 19th May, 2009.

<u>AMENDMENT</u>

In the said Rules, in Part II - General Rules, to rule 5, after the last proviso, the following proviso shall be added, namely:-

"Provided also that this rule shall not apply to destitute widows defined in Explanation I under General Rule 12."
