NOTIFICATION.

In exercise of the powers conferred by Article 318 and proviso to clause (3) of Article 320 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Public Service Commission Regulations, 1954 (Volume I of the Tamil Nadu Services Manual, 1987).

2. The amendment hereby made shall be deemed to have come into force on the 5th January, 2005.

In the said Regulations, in regulation 8, in clause (2), for the words "in addition to the six Under Secretaries", the words "in addition to one Deputy Secretary and six Under Secretaries" shall be substituted.
