Sub: Public Services - Disciplinary Procedures - Format for appointing Inquiry Officer - Modified Format - Adoption - Reg.

In the Handbook on Disciplinary Procedures, a format has been prescribed as Appendix-X for appointing Inquiry Officer to inquire into the charges framed against the Government Servants under Tamil Nadu Civil Services (Discipline and Appeal) Rules 1955. The said format does not speak about the fixing up of the place of inquiry. The need for incorporating guidelines for fixing up of place of inquiry, in the appointment order of Inquiry Officer itself was examined on the suggestion made by Vigilance Commission in a case.

- 2. As per the guidelines in Para 2 (4) in Chapter IV under Part IV the Handbook on Disciplinary Procedures, normally, the hearings will be held at the place where the Government servant was employed at the time of commission or omission of the act or acts forming the ground for the disciplinary proceedings and or where the documentary evidence and witnesses are likely to be readily available. The Inquiring Authority may, however, fix any other place for the Inquiry or different places for different hearings during the course of the inquiry, considering the convenience of the parties concerned with reference to the purpose of each hearing.
- 3. The Government examined the issue in detail and decided to incorporate the above guidelines in the format for appointment of Inquiry Officer at Appendix-X of the Hand Book on Disciplinary Procedures. Accordingly, the Government direct that for existing format at Appendix-X of the Handbook on Disciplinary Procedures, the modified format annexed to this letter may be followed hereafter.
