ORDER:

In the Government Order read above, orders have been issued among other things for substituting the expression "rule 12" for the expression "rule 11" in rule 9 (c)(1)(ii) of the Tamil Nadu Civil Services (Discipline and Appeal) Rules.

It has been noticed that in Tamil Nadu Civil Services (Discipline and Appeal) Rules, the penalties that may be imposed on a Government Servant has been enumerated in rule 8 of the said Rules only and not in rule 12 as substituted in the said Government Order.

2. The existing rule 9(c)(1) is as follows:-

"9(c)(1) The Governor or any other authority empowered by him by general or special order may -

- (i) institute disciplinary proceedings against any Government servant;
- (ii) direct a disciplinary authority to institute disciplinary proceedings against any Government servant on whom that disciplinary authority is competent to impose under these rules any of the penalties specified in rule 12".

3. As such, the Government have decided to amend the said Rules suitably.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Civil Services (Discipline and Appeal) Rules (in Volume I of the Tamil Nadu Services Manual, 1987).

2. The amendment hereby made shall be deemed to have come into force on the 11th February 2008.

AMENDMENT

In the said Rules, in rule 9, in sub-rule (c), in clause (1), in sub-clause (ii), for the expression "rule 12" the expression "rule 8" shall be substituted.
