Sub: Personnel - Tamil Nadu Ministerial Service - Typists and Steno-typists Grade-III appointed temporarily in Tamil Nadu Ministerial Service - Termination of their services - Instructions - Issued.

In the Government Order 1st cited, orders were issued to fill up the vacancies temporarily in the post of Typist and Steno-typist Grade-III in the Tamil Nadu Ministerial

Service through the Commissioner of Technical Education by formulating a scheme till regular candidates are recruited through the Tamil Nadu Public Service Commission. In the Government Order 2nd cited, "Rules of Procedure" for the recruitment of Typists and Steno-typists Grade-III temporarily in the Tamil Nadu Ministerial Service were also issued.

- 2. As per the "Rules of Procedure" ordered in the Government Order 2nd cited, the services of temporary Typists and Steno-typists Grade-III shall not be continued for a period of more than one year. As the period of one year of service of the Typists and Steno-typists Grade-III appointed temporarily under the schemes formulated in the Government Order 2nd cited expires on 03.07.2009 A.N and as their services shall not be continued for a period of more than one year, it has been decided that they may be given a break in service for a day and reappointed again temporarily as Typists and Steno-typists Grade-III.
- 3. Accordingly, the appointing authorities concerned are instructed to terminate the services of all the temporary Typists and Steno-typists Grade-III on 01.07.2009 A.N. irrespective of the date on which they were appointed and to reappoint them afresh on 03.07.2009 F.N. on temporary basis. Termination and appointment orders shall be issued separately by the authorities concerned.
