## ORDER:

In the Government Order first read above sanction have been accorded to create three posts of Commissioner for Disciplinary proceedings in the senior time scale of the Indian Administrative Service and the two post of Deputy Commissioner for Disciplinary proceedings in the grade of District Revenue Officers along with respective jurisdiction.

- 2. Further, in the Government order 2<sup>nd</sup> read above, Government have sanctioned 7 more Commissioner for Disciplinary Proceedings and also reorganised the Commissioner for Disciplinary Proceedings as ten viz. Chennnai, Coimbatore, Madurai, Tirunelveli, Nagercoil, Ramanathapuram, Salem, Vellore, Tiruchi and Thanjavur along with the complement of supporting staff drawn from the Collectorate of the respective Districts.
- 3. In the Government Order 3rd above, the above ten Commissioner for Disciplinary Proceedings have been reduced into 4 Commissioner for Disciplinary proceedings viz. Chennai, Tiruchi, Madurai and Coimbatore and merged with the respective jurisdictions of the nearest Districts.
- 4. There is a steady increase in Directorate of Vigilance and Anti-Corruption cases in recent months, it is felt by the Government that there is an absolute need for recreation of two post of Commissioner for Disciplinary Proceedings at Tirunelveli and Nagercoil with the jurisdiction of the Tirunelveli.

Virudhunager District and Kapniyakumari and Thoothukudi so as to obviate the difficulties of the Government Employees in the Southern Districts

- 5. The Government have accordingly decided that the Commissioner for Disciplinary Proceedings of the Tirunelveli and Nagercoil have to be created and it will function at the above Districts by trifurcating from Madurai Commissioner for Disciplinary Proceedings with immediate effect.
- 6. Sanction is hereby accorded for the creation of two post of Commissioner of Disciplinary Proceedings, in the Super / Senior Time scale of pay of Indian Administrative Service. The posts sanctioned above shall be for a period of one year with effect from the date of employment or the need ceases whichever is earlier.
- 7. Orders regarding the creation of supporting staff, Head of Account and other establishment matters pertaining to the above offices will be issued separately.
