## ORDER:

The Twenty Point Programme – 1986 has been restructured by Government of India called "Twenty Point Programme – 2006" (TPP – 2006) and the Monitoring Mechanism is operational from 1<sup>st</sup> April 2007 onwards. The Government of India have also issued guidelines on TPP-2006 which is available at Government of India website viz. [www.mospi.nic.in](http://www.mospi.nic.in). The guidelines among others, cover monitoring framework and monitoring setup in Central Nodal Ministries and States/UT Administrations. As per the Guidelines, the State Governments have to setup effective monitoring system with the objective of strengthening the planning and implementation machinery under TPP-2006.

2. The Government of India also suggested that the monitoring committees be formed at Block, District and State level to monitor TPP-2006. It is also suggested that the State level committee should meet twice a year, District level committees every quarter and Block level committees every month. In respect of Tamil Nadu, the District Collectors are conducting Review Meetings exclusively for TPP every month and is functioning effectively. The State Government has therefore decided to form the State Level Committee and District Level Committees in Tamil Nadu, based the composition suggested by Government of India.

3. After careful consideration the Government direct that the State and District Level Committees shall be constituted with the following composition:

## I. State Level Committee

**Chairman** : Chief Secretary

**Deputy Chairman** : Secretary to Government (Planning and Development)  
Planning, Development & Special Initiatives  
Department – (Nodal Department)

### Members:

1. Secretary to Government,  
Rural Development and Panchayat Raj Department
2. Secretary to Government, Revenue Department
3. Secretary to Government, Housing & Urban Development Department
4. Secretary to Government, Health & Family Welfare Department
5. Secretary to Government, Environment & Forest Department
6. Secretary to Government, Adi Dravidar & Tribal Welfare Department
7. Principal Secretary to Government, Energy Department
8. Secretary to Government,  
Social Welfare & Nutritious Meals Programme Department
9. Secretary to Government,  
Municipal Administration and Water Supply Department
10. Nominated Social Workers, Educationists and Youth Leaders.

Orders nominating Social Workers, Educationists, Youth Leaders will be issued separately.

## II .District Level Committee:

**Chairman** : District Collector

**Deputy Chairman** : Additional Collector (Development) / Project Officer,  
DRDA.

**Member Secretary** : Personal Assistant (Panchayat Development)

**Members** : District level Officers concerned with TPP, Nomination  
from Minority/SC/ST Community, District Panchayats  
and NGOs (as selected by District Collector)

4. The State Level Committee shall meet twice a year and the District Level Committee shall meet every month. The Minutes of the District Level meetings shall be communicated to Government in Planning, Development & Special Initiatives (MC) Department every month.

5. The District Collectors are authorised to select the members from Minority/ SC/ST Community and NGO's and constitute the District Level Monitoring Committee in respect of respective districts. The copies of the proceedings of the District Collector constituting the committees shall also be sent to Planning, Development & Special Initiatives (MC) Department, besides to other departments concerned.

6. The District Collectors are requested to instruct the Block Level Officers to maintain the targets and list of works completed under various schemes at the Block Level under TPP – 2006, since the Block Level Officers will play a crucial role in the collection of information and the monitoring of schemes.


