### ORDER:

According to the guidelines of the Union Planning Commission, New Delhi for formulation, implementation and monitoring of Scheduled Castes Sub Plan (SCSP) and Tribal Sub Plan (TSP), the department concerned with the welfare and development of Scheduled Castes/Scheduled Tribes in the State Government should be designated as 'Nodal Department' for formulation and implementation of SCSP and TSP. The Government has decided to implement the relevant portion of the guidelines by making the Adi Dravidar and Tribal Welfare Department as 'Nodal Department' for formulation and implementation of SCSP and TSP from the Annual Plan 2006-2007.

#### 2. The Government accordingly issue the following orders:-

- i) The Adi Dravidar and Tribal Welfare department is designated as the Nodal Department for formulation and implementation of the SCSP and TSP.
- ii) The details of the schemes to be implemented under the SCSP and TSP shall be finalised by the Heads of Departments concerned in consultation with the Nodal Department wherever such consultation is deemed necessary by the Nodal Department.
- iii) To give effect to paragraph (ii) above, the Secretary to Government, Adi Dravidar and Tribal Welfare Department or his representative may convene and hold discussions with any Head of Departments who is formulating and implementing schemes under which funds are to be debited to Minor Heads - Code 789 for SCSP and Code 796 for TSP.

- iv) The Nodal Department shall give its views and recommendations within the available budget provisions under the SCSP and TSP Minor Heads (789 / 796) for the budget year 2006-2007 and within expected or planned budget provisions under these Minor Heads for the future financial years.
- v) The Nodal Department shall monitor the implementation of schemes under the SCSP and TSP.
- vi) Cases where the Head of Department does not accept the views or recommendations of the Adi Dravidar and Tribal Welfare Department shall be referred to Government in the concerned Administrative Department. Such cases shall be dealt with in Government in accordance with the Tamil Nadu Government Business Rules, in consultation with the Adi Dravidar and Tribal Welfare Department.
- vii) The above orders take effect from the Annual Plan 2006-2007.

3. This orders issues with the concurrence of Adi Dravidar and Tribal Welfare Department vide its U.O.No.26/S/AD&TW/2006, dated 29.8.2006.
