ORDER :-

As per Special Rules for the Tamil Nadu General Subordinate Service in Class XLIII Department of Economics and Statistics in rule 4, the educational qualifications prescribed for the posts of Assistant Statistical Investigator and Statistical Inspector through direct recruitment and recruitment by transfer are "A degree in Mathematics, Statistics or Economics as the main subject".

2. In the letter first read above, the Principal Secretary and Director, Department of Economics and Statistics has stated that the said educational qualifications have been fixed long ago. More requirements are emerging for Government departments and other data users in the areas of Computer Applications and Quantitative Analysis. To suit the present needs, it has become necessary to amend the educational qualifications prescribed for the post of Assistant Statistical Investigator and Statistical Inspector included in the Special Rules for Class XLIII of Tamil Nadu General Subordinate Service for both direct recruitment and recruitment by transfer.

3. As per the existing rule 2 of Tamil Nadu General Subordinate Service Special Rules, 20% of the vacancies in the post of Statistical Inspector are to be filled by direct recruitment. The educational qualifications hitherto prescribed for both Assistant Statistical Investigator and Statistical Inspector are identical and as such Direct Recruitment in the category of Statistical Inspector will serve no useful purpose and will only hamper promotion opportunities of the holders of the feeder post of Assistant Statistical Investigator eventually leading to demoralisation. Therefore, it has been decided to do away with Direct Recruitment in the category of Statistical Inspector.

4. In the Department of Economics and Statistics, the post of Statistical Inspector is an important and critical post. The Assistants, however, are basically clerical staff having no technical knowledge of statistical activities. The department's professional need and input to policy is more critical and important. Further, since Assistant Statistical Investigators work on special tasks and are groomed over several years for the post of Statistical Inspector, a minimum tenure of five years is considered necessary for promotion as Statistical Inspector within which they should complete three years of field experience in districts other than Chennai. Therefore, it is decided to do away with the method of recruitment for the post of Statistical Inspector from the category of Assistant in the Department of Economics and Statistics.

5. In the light of the above position, the Government amend the Special Rules for Class XLIII of Tamil Nadu General Subordinate Services.

8. The following notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to the Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for Class XLIII of the Tamil Nadu General Subordinate Service (Section 13 under Part-II of the Service Rules in Volume-III of the Tamil Nadu Services Manual, 1969).

2. The amendments hereby made shall come into force on and from the date of issue of this Notification.

AMENDMENTS

In the said Special Rules, in Part-II, in Class XLIII,

1) In **Rule 2** under the heading **Statistical Inspectors**, the existing entries and the Provisos and Explanation thereunder shall be substituted with the following:-

STATISTICAL INSPECTORS:

By Promotion from the category of Assistant Statistical Investigator.

2) In **Rule 4**, order in the Table,

i) Against the Category "**Statistical Inspector**" in column (1), the entries "Direct Recruitment" in column (2) and qualifications for Direct Recruitment in column (3) shall be deleted.

ii) For the entry in column (3) against the Category "Statistical Inspector" in column (1) the word "or recruitment by transfer" occurring in column (2) shall be deleted.

iii) for the entry in column (3), against the Category "Statistical Inspector" in column (1) and "Promotion" in column (2) thereon, the following entry shall be substituted, namely :-

a) Degree in Statistics;

OR

Degree in Mathematics/Computer Science/Economics/Computer Applications with Statistics as an ancillary/allied subject;

OR

Any degree with Post graduate degree in Operations Research/Econometrics/Mathematical Economics.

b) Must have put in a service of not less than five years in the category of Assistant Statistical Investigator.

Provided that the qualifications specified above shall not be insisted upon in respect of existing incumbents in the post of Assistant Statistical Investigator as on the date of issue of this notification:

Provided further, that field experience of three years, in districts other than Chennai in field-level collection of statistical data in the post of Assistant Statistical Investigator in any of the schemes in the District shall be necessary prerequisite for which no relaxation shall be considered under any circumstances whatsoever.

iv) for the entry in column (3), against the category "**Assistant Statistical Investigator**" in column (1) and "**Direct recruitment**" in column (2) thereon, the following entry shall be substituted, namely:-

a) Degree in Statistics;

OR

Degree in Mathematics/Computer Science/Economics/Computer Applications with Statistics as an ancillary/allied subject;

OR

Any degree with Post graduate degree in Operations Research/Econometrics/Mathematical Economics.

Provided the candidates with the above degrees other than Statistics are expected to be fully conversant with basic level concepts of Statistics including Bayes' theorem in Probability, Probability

distributions like Binomial, Poisson, Normal, t, Chi-Square & F, Probability Generating Functions, Moment Generating Function, Theory of Estimation, Testing of Hypothesis using various Statistical Tests like Z, t, F, Chi-Square, basics of Multiple Regression and Multivariate analysis and Sampling design. In addition, they should have basic skills in using MS-Excel for statistical data analysis.

- b) Must not complete or must not have completed 30 years of age on the 1st day of July of the year in which the selection for appointment is made.

*) for the entry in column (3), against the category "**Assistant Statistical Investigator**" in column (1) and "**Recruitment by transfer**" in column (2) thereon, the following entry shall be substituted, namely:-

- a) Degree in Statistics;
OR
Degree in Mathematics/Computer Science/Economics/Computer Applications with Statistics as an ancillary/ allied subject;
OR
Any degree with Post graduate degree in Operations Research/Econometrics/Mathematical Economics.
- b) Must have put in a service of not less than three years in the category of Junior Assistant or Typist as the case may be.
- c) Must have passed the Departmental Test on Statistics.
