ORDER:

In the letter first read above, the Chairman, Teachers Recruitment Board has stated that based on the equivalence certificate issued by various universities, candidates are applying for the recruitment for the post of B.T. Teachers and in this regard he has requested to issue clarification regarding the equivalence of 23 subjects. In the Government letter second read above the Secretary, Tamil Nadu Public Service Commission was requested to place the above subjects before the Equivalence Committee for considering as Equivalent to the qualification prescribed for the post of B.T. Teachers.

- 2. The High Court of Madras in its order third read above granted four weeks time to the Government to communicate the decision of the Committee.
- 3. Based on the orders of the High Court, Madras the question as to whether the degrees mentioned in Column 2 are considered as equivalent to the degrees mentioned in Column 3 in the following table.
