#### **Order:**

The Principal Secretary / Commissioner of Tourism in his letter read above, has sent necessary proposals as received from the District Collector, Coimbatore for the development of infrastructure facilities of Park and play ground in the Kandasamy park area at Municipal limit Pollachi in Coimbatore District at a total cost of Rs.50.00 lakhs.

2. The Commissioner of Tourism has further stated that he has examined the above proposal of the District Collector, Coimbatore and the implementation of the above project is essential for the tourists and devotees visiting Kovai Courtrallam, Marudhamalai, Udhagamandalam from Pollachi and its surrounding areas in Coimbatore District, and also for the benefit of the students of schools and colleges functioning in Pollachi.

3. The Commissioner of Tourism has therefore requested to sanction the entire plan estimate of Rs.50.00 lakhs, with 100% Tourism Department's share, as a special case and to accord financial sanction.

4. The Government after careful examination, accept the proposal of the Principal Secretary / Commissioner of Tourism and issue order as follows: -

- i. Administrative sanction is accorded for the development of a Park and play ground in the Kandhasamy Park area at Pollachi Municipal limits, in Coimbatore District at an estimated cost of Rs.50.00 lakhs (Rupees Fifty lakhs only);
- ii. Financial sanction is accorded for a sum of Rs.25.00 lakhs (Rupees Twenty Five lakhs only) for the above said work;
- iii. The balance amount of Rs.25.00 lakhs (Rupees Twenty Five lakhs only) shall be met out of contribution from respective local body (or) from the MLA/MP Constituency Development Fund;
- iv. The Principal Secretary/Commissioner of Tourism shall draw and disburse the amount to the District Collector, Coimbatore for executing the work by the Municipal Commissioner, Pollachi, Coimbatore District.

5. The amount sanctioned at para 4 above shall be debited under the following Head of Account: -

“5452-Capital Outlay on Tourism-01-Tourist Infrastructure-101-Tourist Centres – Schemes in the Twelfth Five Year Plan-II State Plan-KV Improvement of basic facilities in Tourist Centres – 16 Major Works” (DPC 5452 01 101 KV 1604).

6. Necessary additional funds will be provided in RE/FMA 2012-2013. Pending provision of such funds, the Principal Secretary/Commissioner of Tourism is authorized to draw and disburse the amount sanctioned in para 4(ii) above and include the same while sending proposals for RE/FMA 2012-2013 to Government in Finance (Edn-II) Department.

7. The Principal Secretary / Commissioner of Tourism shall send report on the progress of above works and Completion Report / Utilisation Certificate to Government.
