ORDER:

During the All Collectors and Police Officers Conference held from 17.12.2012 to 19.12.2012, the following announcement has been made by the Hon'ble Chief Minister.

“ Muthupet Lagoon in Tiruvarur District will be developed as Eco-Tourism Centre”.

2. In this connection, the Principal Secretary / Commissioner of Tourism in his letter third read above, has stated that the District Collector, Tiruvarur has furnished a proposal for “Development of infrastructure facilities at Muthupet Lagoon area in Tiruvarur District” at an estimated cost of Rs.217.80 lakhs with the following components:

3. The Principal Secretary/Commissioner of Tourism has requested to consider and approve the scheme "Development of infrastructure facilities at Muthupet Lagoon area in Tiruvarur District" and sanction a sum of Rs.217.80 lakhs (Rupees Two hundred seventeen lakhs and eighty thousands only).

4. The Government after careful examination accept the above proposal of the Principal Secretary/ Commissioner of Tourism and orders as follows:

- i. Administrative and financial sanction is accorded for the development of infrastructure facilities at Muthupet Lagoon area in Tiruvarur District, at a total cost of Rs.217.80 lakhs (Rupees Two hundred seventeen lakhs and eighty thousand only), to carry out the works mentioned at para 2 above.
- ii. The Principal Secretary /Commissioner of Tourism is authorised to draw the amount sanctioned above and permitted to disburse the amount to the District Collector, Tiruvarur and to execute the works through District Forest Officer, Tiruvarur and Block Development Officer, Tiruvarur as mentioned at para 2 above.

5. The amount sanctioned above shall be debited in the following head of account:

"5452-Capital Outlay on Tourism – 01- Tourist Infrastructure -101 – Tourist Centres – Schemes in the Twelfth Five Year Plan-II State Plan – KV - Improvement of Basic Facilities in Tourist Centres – 16 Major Works." (DPC 5452 01 101 KV 1604)

6. The Principal Secretary/ Commissioner of Tourism shall ensure that necessary arrangements are made in the Muthupet in Tiruvarur District, to visibly indicate that the above works were carried out through State Tourism Department Funds.
