ORDER:

While moving the Demand for Tourism, for the year 2013-14, the Hon'ble Minister for Tourism has made the following announcement in the Legislative Assembly.

"The Hon'ble Chief Minister has ordered to provide basic facilities at 14 important tourist centres, at a total cost of Rs.10.58 crores... .. including Viralimalai, Thirumanancherry, Thirupunavasal, in Pudukottai District."

2. In the letter second read above, the Principal Secretary/ Commissioner of Tourism has stated that the District Collector, Pudukottai has sent a proposal for providing the basic facilities at Sri Sugantha Parimalaswarar Temple area in Thirumanancherry in Pudukottai District, at an estimated cost of Rs.37.15 lakhs, for the following component of works:-

3. The Principal Secretary/Commissioner of Tourism has stated that the District Collector has recommended to provide the above basic facilities, at Sri Sugantha Parimaleswarar Temple area in Thirumanancherry in Pudukottai District, which are essential and would be very useful for the benefit of the visiting tourists and pilgrims. He has therefore requested that based on the tourism development importance of Pudukottai District and the requisition made by the District Collector Pudukottai, a sum of Rs.37.15 lakhs (Rupees thirty seven lakhs and fifteen thousand only) may be sanctioned from tourism funds, to execute the above mentioned works.

4. The Government after careful examination of the proposal of the Principal Secretary/Commissioner of Tourism have decided to accept and accordingly issue the following orders:-

- i. Sanction is accorded to Principal Secretary/ Commissioner of Tourism for a sum of Rs.37.15 lakhs (Rupees thirty seven lakhs and fifteen thousand only), for providing the basic facilities at Sri Sugantha Parimaleswarar Temple area in Thirumanancherry in Pudukottai District, as mentioned at para 2 above.
- ii. The Principal Secretary / Commissioner of Tourism is authorized to draw the amount sanctioned above and permitted to disburse it to the District Collector, Pudukottai and execute the works through the Block Development Officer, Karambakudi Panchayat Union.

5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-

“5452-Capital Outlay on Tourism-01-Tourist Infrastructure-101-Tourist Centres – Schemes in the Twelfth Five Year Plan-II State Plan-KV Improvement of basic facilities in Tourist Centres – 16 Major Works“

6. Necessary additional funds will be provided in the RE/FMA 2013-2014. Pending provision of funds in RE/FMA 2013-2014, the Principal Secretary/ Commissioner of Tourism is authorized to draw and disburse the amount sanctioned at para 4 above. The Principal Secretary/ Commissioner of Tourism is requested to send necessary proposal for inclusion of the amount in the RE/FMA 2013-2014 to Government in Finance (Edn.II) Department without fail.

7. The Principal Secretary/Commissioner of Tourism shall ensure that necessary arrangements are made in Sri Sugantha Parimaleswarar Temple in Thirumanancherry in Pudukottai District to visibly indicate that the above works were carried out through “STATE TOURISM DEPARTMENT FUNDS”.

8. The Principal Secretary / Commissioner of Tourism shall send a report on the progress of above works and Completion Report / Utilization Certificate to Government.

9. This order issues with the concurrence of Finance Department vide its U.O. No.56344/Edn.II/2013, dated: 18.10.2013 with Additional Sanction Ledger No.1701 (One thousand seven hundred and one).
