1. Announcement made by Hon'ble Minister for Tourism for the year 2013-2014.
2. From the Principal Secretary/ Commissioner of Tourism letter No.7290/PD2/2012 and Letter No.7333/PD2/2012, dated: 14.5.2013.

ORDER:

While moving the demand for Tourism Department for the year 2013-2014, the Hon'ble Minister for Tourism has made the following announcement in the Legislative Assembly.

“The Hon'ble Chief Minister has ordered to provide Basic infrastructure facilities in 14 important tourist centres, at a total cost of Rs.10.58 crores, including Kangeyampalayam, in Erode District.”

2. In the letters second read above, the Principal Secretary/Commissioner of Tourism has forwarded a proposal of the Commissioner of Hindu Religious & Charitable Endowments for providing the following basic facilities at Arulmigu Nattatheeswarar Temple in Kangeyampalayam, Erode District, for the benefit of the devotees and tourist visiting the above temple .

3. The Principal Secretary/Commissioner of Tourism has stated that, considering the tourism importance of the Erode District, the above proposal of the Commissioner of Hindu Religious & Charitable Endowments is recommended to the Government. He has therefore requested that the above proposal may be accepted and a sum of Rs.20.90 lakhs (Rupees twenty lakhs and ninety thousand only) may be sanctioned, to carry out the works mentioned at para 2 above.

4. The Government after careful examination of the proposal of the Principal Secretary/ Commissioner of Tourism have decided to accept it and accordingly issue following orders:-

- i. Sanction is accorded to the Principal Secretary/ Commissioner of Tourism, for a sum of Rs.20.90 lakhs (Rupees twenty lakhs and ninety thousand only) for providing the basic facilities as mentioned at para 2 above, to Arulmigu Nattatheeswarar Temple in Kangeyampalayam, Erode District
- ii. The Principal Secretary/Commissioner of Tourism is authorised to draw the amount sanctioned above and permitted to disburse the same to the Commissioner of Hindu Religious & Charitable Endowments, Chennai to execute and maintain the works.

5. The amount sanctioned at para 4 above shall be debited under the following head of account:

“5452 – Capital Outlay on Tourism -01 – Tourist Infrastructure -101 – Tourist Centres – Schemes in the Twelfth Five Year Plan-II – State Plan – KV – Improvement of basic facilities in Tourist Centres – 16 Major Works”

6. Necessary additional funds will be provided in RE/FMA 2013-2014 to meet the expenditure sanctioned above. Pending provision of such funds in RE/FMA 2013-2014, the Principal Secretary/Commissioner of Tourism shall draw and disburse the amount sanctioned to the executing agencies and requested to include the same while submitting the proposals for RE/FMA 2013-2014 along with a copy of this Government Order, to Government in Finance (Edn II) Department.

7. The Principal Secretary/ Commissioner of Tourism shall ensure that necessary arrangements are made in Arulmigu Nattatheeswarar Temple area in Kangeyampalayam, Erode District, to visibly indicate that the above works were carried out through “State Tourism Department Funds”.

8. The Principal Secretary/ Commissioner of Tourism shall send a report on the progress of above works and Completion Report/ Utilisation Certificate to Government.

9. This orders issues with the concurrence of Finance Department vide its U.O.No.56327/Edn-II/2013, dated: 17.10.2013, with Additional Sanction Ledger No.1680 (One thousand six hundred and eighty)
