ORDER:

The Government of India have given administrative approval for Rs.72.75 crore to implement Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) for the year 2015-16.

- 2. In the Government Order second read above, Government have sanctioned and released a sum of Rs.6998.55 lakh towards the implementation of Pradhan Mantri Krishi Sinchayee Yojana during 2015-16 as per the previous year (2014-15) subsidy pattern as first phase. Further it has been ordered that the additional share amount of Tamil Nadu as per the Pradhan Mantri Krishi Sinchayee Yojana will be sanctioned later.
- 3. In the Government of India letter first read above, Government of India have revised the funding pattern of Micro Irrigation scheme under Pradhan Mantri Krishi Sinchayee Yojana between Central and state Government as 60:40.
- 4. In the Government Order third read above Government have sanctioned and released as balance of First installment a sum of Rs.3298.9168 lakh towards the implementation of Pradhan Mantri Krishi Sinchayee Yojana during 2015-16 in the ratio of 60:40 (GOI:State)

- 5. In the letter fourth read above, Government of India have released an amount of Rs.3601.1198 Lakh as second instalment i.e Rs.2837.24 Lakh for General Category and Rs.763.88 Lakh for SCSP category for the implementation of Pradhan Mantri Krishi Sinchayee Yojana during 2015-16.
- 6. In the letter fifth read above, the Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government, to sanction and release the amount of Rs.6710.7179 Lakh (for General Category Rs.5567.3259 Lakh + SCSP Category Rs.1143.3920 Lakh) for the smooth and successful implementation of Micro Irrigation scheme under Pradhan Mantri Krishi Sinchayee Yojana for the year 2015-16.
- 7. The Government after careful examination, accept the proposal of Managing Director, Tamil Nadu Horticulture Development Agency and accordingly sanction and release a sum of Rs.6710.7179 Lakh (Rupees Sixty seven crore ten Lakh seventy one thousand seven hundred and ninety only) (for General Category Rs.5567.3259 Lakh + SCSP Category Rs.1143.3920 Lakh) towards the smooth and successful implementation of Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana during 2015-16 in Tamil Nadu. The balance amount will be provided next financial year 2016-2017.
