ORDER:

During the Eleventh State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 29.01.2014 under the chairmanship of Chief Secretary to Government, the following project proposal of Tamil Nadu Civil Supplies Corporation was placed and approved, subject to getting clearance after sending the project details to the Marketing division of Government of India and to take up 15 Nos. during 2014-15 and 10 Nos. during 2015-16:-

2. Accordingly, the Chief Engineer, Tamil Nadu Civil Supplies Corporation has sent detailed project report for construction of 15 Nos. of direct purchase centre for the year 2014-15 at a cost of Rs.525.00 lakh under National Agriculture Development Programme to Government of India for approval.

- 3. The Government of India has given its approval for the above project with the recommendation of providing 25% of assistance of the project cost as per para 4.3 and 4.6 of the revised Rashtriya Krishi Vikas Yojana operational guidelines 2014.
- 4. Subsequently, Government of India in its explanatory memorandum has clarified that the concept of the beneficiary contribution would only arise in the case of non-State actors and in case of Governmental and Quasi Governmental agencies, the State will be the beneficiary. Accordingly, all Government (Centre / State) and quasi-Government (fully funded organization), State Agriculture Universities, Panchayati Raj Institutions, Primary Agriculture Credit Societies (PACS) etc., may be entitled to 100% funding of project cost under Rashtriya Krishi Vikas Yojana for creation of assets / infrastructure to promote activities in agriculture and allied sectors.
- 5. In this regard, the Managing Director, Tamil Nadu Civil Supplies Corporation has informed that Tamil Nadu Civil Supply Corporation is a Government of Tamil Nadu undertaking and is functioning with the assistance of Government subsidy only and is eligible for 100% subsidy and has requested the Government to sanction an amount of Rs.525.00 lakh for the project "Construction of 15 Nos. of Direct Purchase Centres in the Delta & Non Delta Districts of Tamil Nadu" under National Agriculture Development Programme for the year 2014-15.
- 6. The Government after careful examination, accord approval for the following detailed project proposal of Tamil Nadu Civil Supplies Corporation at a cost of Rs.525.00 lakn (Rupees Five Crore and Twenty five lakh only) and sanction accordingly an amount of Rs.525.00 lakh for the above purpose under National Agriculture Development programme / Rashtriya Krishi Vikas Yojana for 2014- 2015 to the implementing agency i.e. Tamil Nadu Civil Supplies Corporation, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted:-

- 9. The funds available under existing Centrally Sponsored Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above project. The project should follow centrally prescribed cost norms and approved pattern of assistance. The Department of Tamil Nadu Civil Supplies Corporation should take due care to ensure that there is no duplication of subsidy.
- 10. The Commissioner of Civil Supplies and Consumer Protection should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the scheme.
- 11. The Commissioner of Civil Supplies and Consumer Protection is directed to follow the operational guidelines of National Agriculture Development Programme while implementation of the above scheme.
- 12. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the HOD's concerned to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.
- 13. The Executive Director, Tamil Nadu Watershed Development Agency, Chennai is requested to send the monthly progress report to Government of India, in the prescribed format by 10th of the subsequent month under intimation to this Government without fail.
