ORDER:

In the Government Order first read above administrative orders have been issued for construction of Dormitories at 5 places in Chennai and Sub-urban and one place each in Tiruchirappalli, Madurai, Salem and Coimbatore at a cost of Rs.106,00,00,000/- (Rupees one hundred and six crore only), by utilizing the Construction Workers Welfare Fund.

2. In the letter second read above the Commissioner of Labour has sent detailed estimate for the construction of dormitory to accommodate 250 persons at Kottapattu Village in Tiruchirappalli District, at a cost of, Rs.6,05,00,000/- (Rupees six crore five lakh only), prepared by the Chief Engineer (Building), Public Works Department.

After careful consideration the Government accord permission to release Rs.5,29,37,500/- (Rupees Five crore twenty nine lakh thirty seven thousand and five hundred only), excluding centage charges, from Tamil Nadu Construction Workers Welfare Fund to construct dormitory to accommodate 250 construction workers at Kottapattu Village in Tiruchirappalli District.

4. The Commissioner of Labour is requested to send monthly periodical report to Government on the implementation of the scheme.
