ORDER:

In the Government Order first read above, a Committee was constituted under section 5 (1) (a) of the Minimum Wages Act, 1948 (Central Act XI of 1948) to hold the enquiries and advise them in the matter of fixation of minimum rates of wages for the employment in Textile Mills including Composite Mills, Spinning Mills, Weaving Mills, Open Ended Mills and the various processes in the above said mills like blow room, carding, drawing, fly frames, spinning, winding, doubling, reeling, packing, warping – sizing and other processes in the Textile Mills, whether carried out singly or together (other than apprentices) and notified in the Tamil Nadu Government Gazette as Notification No. II (2)/LE/257/2010 in Part II-Section 2, dated 5.5.2010.

2. In the Government Order second read above, the name of Thiru S. Radhakrishnan was deleted as member of Employer's Representative as he has retired from National Textile Corporation Limited on superannuation and the name of Thiru S. Dinakaran, Salem was substituted.

3. The Commissioner of Labour in his letters third read above has requested the Government to add one more member both as Employers' Representative and Employees' Representative.

4. The Government, after careful examination, accept the proposal of the Commissioner of Labour and have now decided to appoint one more member as Employers' representative and Employees' representative.

5. The appended Notification will be published in the Tamil Nadu Government Gazette both in English and Tamil. The Works Manager, Government Central Press,
