In pursuance of the orders issued vide Government Order first read above, the following Notification will be published in the <u>Tamil Nadu Government Gazette</u>:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Employment and Training Subordinate Service (Section 7B of the Tamil Nadu Service Manual Volume-III).

2. The amendment hereby made shall be deemed to have come into force on the 17th November 1998.

AMENDMENT

In the said Special Rules, in rule 2, in the tabular column under sub-rule (a), under the heading "CLASS-I," in column (2), for item (ii), against the Category "3. Junior Training Officers in various Trades including Drawing and Mathematics in the Industrial Training Institutes / Centres," in column (1) thereof, the following shall be substituted, namely:-

"(ii) By direct Recruitment in the ratio 1:1:1 as between,-

- (a) National Trade Certificate holders;
- (b) National Apprenticeship Certificate holders; and
- (c) Diploma Holders,"
