ORDER:

In the Government Order first read above, a Committee was appointed under the chairmanship of the Deputy Commissioner of Labour, Salem for fixation of minimum rates of wages for the Employment in Folding Textile goods. The said Committee conducted various meetings with the employers and employees and submitted a report to the Commissioner of Labour.

2. The Commissioner of Labour in his letter second read above, has sent the report of the said Committee along with his recommendations to the Government for the fixation of minimum rates of wages for the Employment in Folding Textile goods.

3. The Government have carefully examined the report of the said Committee and the recommendations of the Commissioner of Labour. The Government have decided to accept the recommendations of the Commissioner of Labour, Chennai - 600 006 and accordingly decided to fix the minimum rates of wages for the Employment in Folding Textile goods.

4. The appended Notification will, accordingly, be published in the Tamil Nadu Government Gazette both in English and Tamil. The Works Manager, Government Central Press, Chennai - 600 001 is requested to send each five copies of the Gazette Notification to the Government and to the Commissioner of Labour, Chennai - 600 006, for reference and record. The Director, Tamil Development and Information (Translation) Department, Secretariat, Chennai - 600 009 is requested to

send the Tamil translation of the Notification to the Works Manager, Government Central Press, Chennai - 600 001.

APPENDIX.
NOTIFICATION.

In exercise of the powers conferred by clause (a) of sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948), the Governor of Tamil Nadu, after considering the advice of the Committee appointed under clause (a) of sub-section (1) of section 5 of the said Act, hereby fixes the minimum rates of wages payable to the classes of employees in the Employment in Folding Textile goods in the State of Tamil Nadu specified in column (1) of the Schedule below as specified in the corresponding entries in column (2) thereof:-

(2) This Notification shall come into force on and from the date of its publication in the Tamil Nadu Government Gazette.

THE SCHEDULE.

Employment in Folding Textile goods.

<u>Classes of employees.</u> (1)	<u>Minimum rate of basic wages.</u> <u>(per month)</u> (Rs.P) (2)
Employees engaged in Folding Textiles	6076.00

Explanations .- (1) Dearness Allowance.- In addition to the minimum rates of basic wages fixed above, the employees shall be paid dearness allowance as indicated below:-

- (i) The dearness allowance is linked to the Average Consumer Price Index of Chennai City for the year 2010, that is, 161 points (with base year 2001=100) and for any further raise of every one point over and above 161 points, an increase of Rs.37.70 (Rupees thirty seven and paise seventy only) per month shall be paid as dearness allowance.
- (ii) The dearness allowance shall be calculated every year on the first April, on the basis of the average of the indices for the preceeding twelve months, namely from January to December.
- (iii) The first calculation shall thus be effective from the date of publication of this Notification in the Tamil Nadu Government Gazette.

- (2) Where the nature of work is the same, no distinction in the payment of wages shall be made between the male and female employees.
- (3) To arrive at daily rate of wages, the monthly wages shall be divided by 26.
- (4) Wherever the existing wages are higher than the minimum wages fixed herein, the same shall be continued to be paid.
