ORDER:

In the Government Order first read above, the minimum rates of wages for the employment in Laundries and Washing Clothes (including Woollen) were revised under the provisions of the Minimum Wages Act, 1948 (Central Act XI of 1948).

- 2. In the Government Order Second read above, a Preliminary Notification was issued to revise further the minimum rates of wages for the above said employment.
- 3. The Commissioner of Labour in his letter third read above, has stated that objection and suggestion received from the persons, likely to be affected by such revision were placed before the Minimum Wages (State) Advisory Board and the Board has decided to confirm the said Preliminary Notification without any modification and hence he has requested the Government to confirm the above said Preliminary Notification without any modification.
- 4. The Government after careful examination have decided to confirm the orders issued in the Preliminary Notification.
- 5. The appended Notification will, accordingly, be published in the <u>Tamil Nadu Government Gazette</u> both in English and Tamil. The Works Manager, Government Central Press, Chennai 600 079 is requested to publish the Notification and send five copies of the Gazette to the Government and to the Commissioner of Labour, Chennai-6 for reference and record. The Director, Tamil Development and Information

APPENDIX. NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948) and in supersession of the Labour and Employment Department Notification No. II(2)/LE/684/2013 published at page 605 and 606 of Part II- Section 2 of the <u>Tamil Nadu Government Gazette</u>, dated 4th September 2013, the Governor of Tamil Nadu, after consultation with the Advisory Board, hereby revises the minimum rates of wages payable to the classes of work in the employment in laundries and washing clothes (including woollen) in the State of Tamil Nadu specified in column (2) of the Schedule below, as specified in the corresponding entries in column (3) thereof, the draft of the same having been previously published as required by clause (b) of sub-section (1) of section 5 of the said Act.

2. This notification shall come into force with effect on and from the date of its publication in the <u>Tamil Nadu Government Gazette</u>.

THE SCHEDULE.
Employment in laundries and washing clothes (including woollen).

(1)	Washing clothes in laundries covered by the Factories Act, 1948 (Central Act 63 of 1948) or Employees' State Insurance Scheme or Employees' Provident Fund Scheme.	337.00
(2)	Ironing clothes in laundries covered by the Factories Act 1948 (Central Act 63 of 1948) or Employees' State Insurance Scheme or Employees' Provident Fund Scheme.	343.00
(3)	Washing clothes in laundries other than those mentioned in item (1) above.	342.00
(4)	Ironing clothes in laundries other than those mentioned in item (2) above.	349.00

Explanations.- (1) The Minimum rates of wages shall be paid in cash.

- (2) <u>Dearness Allowance</u>.- In addition to the minimum rates of basic Wages mentioned above, the employees shall be paid dearness allowance as indicated below:-
 - (i) The wages notified above shall be linked to the average Chennai City Consumer Price Index for the year 2010, i.e., 161 points with base 2001=100 and for every rise of one point over and above 161 points, an increase of Rs.2.05 (Rupees two and five paise only) per day shall be paid as dearness allowance.
 - (ii) The dearness allowance shall be calculated from the 1st April of every year on the basis of the average of the indices for the earlier Twelve months, that is, from January to December.
 - (iii) The revision shall be effective from the date of publication of the Notification in the <u>Tamil Nadu Government Gazette</u> based on the Average Consumer Price Index of the previous year (i.e. from January to December)
- (3) Where the nature of work is the same, no distinction in the payment of wages shall be made between men and women employees.
- (4) The daily rate of wages and dearness allowance shall include the element of holiday wages also.
- (5) To arrive at monthly rates of wages, the daily wages shall be multiplied by 30.
- (6) Wherever the existing wages are higher than the minimum wages fixed herein, the same shall be continued to be paid.
