ORDER:

In the Government Order first read above, orders were issued to include employment in Dimexen Industry to Part – I of the Schedule to the Minimum Wages Act, 1948 (Central Act XI of 1948) and it was published as the Labour and Employment Department Notification No.II(2)/LE/424/2002 on page 295 in part II – section 2 of the Tamil Nadu Government Gazette, dated the 15th May 2002.

2) In the Government Order second read above, a Preliminary Notification was issued to amend the name of “Employment in Dimexen Industry” as “Employment in Diamond Cutting and Polishing Industry”.

3) In the letter third read above, the Principal Secretary /Commissioner of Labour has stated that no objection and suggestion were received from the persons likely to be affected by such notification and the Minimum Wages (State) Advisory Board has recommended to confirm the Preliminary Notification and hence he has requested to confirm the above said Preliminary Notification without any modification.

4) The Government, after careful examination, accept the proposal of the Commissioner of Labour and have decided to confirm the orders issued in the said Preliminary Notification.

5) The appended Notification will, accordingly, be published in the Tamil Nadu Government Gazette both in English and Tamil. The Works Manager, Government Central Press, Chennai-600 079 is requested to publish the Notification and send five copies of the Gazette to the Government and to the Commissioner of Labour,

Chennai-6 for reference and record. The Director, Tamil Development and Information (Translation) Department, Secretariat, Chennai-600009 is requested to send the Tamil Translation of the Notification to the Works Manager, Government Central Press, Chennai-600 079.
