**ORDER:**

The Registrar General, High Court, in his letter read above has sent the proposal to Government for Constitution of Additional Labour Court at Madurai and requested for sanction of the following staff:-

2. After careful examination of the proposal of the Registrar General, High Court, the Government hereby ordered as follows:-

a) Sanction is accorded for constitution of Additional Labour Court at Madurai.

b) Sanction is also accorded for the creation of following posts for the above Additional Labour Court:-

Sanction is also accorded for a sum of Rs.40,22,670/- (Rupees Forty Lakh Twenty Two Thousand Six Hundred and Seventy Only) towards Salaries, Rs.24,000/- (Rupees Twenty Four Thousand Only) for telephone charges and Rs.7,000/- ( Rupees Seven Thousand Only) for purchase of Library books as recurring expenditure.

c) Sanction is also accorded for the following non-recurring expenditure:-

(c) Provision of IT products to the Judicial Officer will be dealt separately based on the norms.

d) Out of three posts of Office Assistant sanctioned in (b) above for the said Additional Labour Court, one post of Office Assistant should be surrendered if any need arises for Driver post in future.

e) The Director, Stationery and Printing, Chennai is requested to supply required Forms, Registers, Stationery, 2 English Typewriters and 2 Tamil Typewriters at free of cost.

3. The expenditure sanctioned in para 2 above shall be debited to the following Head of Account :-

4. The expenditure sanctioned in para 2 above shall constitute an item of "New Instrument of Service" and the approval of Legislature shall be obtained in due course of time. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the contingency Fund. The Registrar General, High Court is requested to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G.I) Department directly in Form 'A' appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G.I) Department. The Registrar General, High Court is also requested to send necessary explanatory notes to the Government in Finance (Home II) Department for inclusion of this expenditure in the Supplementary Estimates for the year 2017-2018, at the appropriate time without fail.

5. The incumbents of newly created posts at para 2 above are eligible to draw pay and other allowances as per orders in force.

6. This order issues with the concurrence of the Finance Department vide its U.O. No.18644 / Finance (CMPC) / 2017, dated 05.04.2017 and Additional sanction Ledger No.24 (Twenty four).
