### ORDER:

In the letter 1<sup>st</sup> read above, orders were issued that the upper age limit in admission for women candidates in the Government Industrial Training Institutes for women and 3 women wings of General Government Industrial Training Institutes has been removed. In the places where no women Industrial Training Institute is available, the woman candidates are seeking admission in the General Government Industrial Training Institutes. The upper age limit for the women candidates seeking admission in General Government Industrial Training Institutes have not been removed and the upper age limit of 40 years is being followed.

2. Hence, to facilitate more women candidates to get admission in all Industrial Training Institutes, to acquire vocational skills and to safeguard their position in the society, during the Budget session, 2014-2015, the Hon'ble Minister for Labour has made the Announcement on the floor of the Assembly on 11.7.2014 that **the upper age limit for Women candidates seeking admission in General Government**

**Industrial Training Institutes will be removed from the year 2014-2015 .**

3. In the letter 2<sup>nd</sup> read above, the Director of Employment and Training has stated that there is no bar in upper age limit for the admission in the Industrial Training Institutes both for men and women candidates as per National Council for Vocational Training (NCVT) norms and also recommended that the present age restriction of 40 years for admission into the General Government Industrial Training Institutes shall be removed on par with the norms available for admission in women Industrial Training Institutes and women wings. He has also stated that no additional expenditure is involved in this proposal.

4. After careful examination, the Government issue orders that the upper age limit of 40 years for admission into General Government Industrial Training Institutes is removed for women with effect from the academic year 2014-2015.
