4. மேலே மூன்றாவதாக படிக்கப்பட்ட கடிதத்தில், மேற்காணும் அறிவிப்பினை செயல்படுத்தும் விதமாகவும், அதிக அளவிலான மாணவர்கள் பயன்பெற ஏதுவாகவும் அரசாணை (நிலை) எண்.115, ஆதி(ம)பந துறை, நாள் 02.12.2022-இல் அயல்நாடு சென்று உயர்கல்வி பயிலும் திட்டத்தின் திட்டப்பகுதி 2-ற்கு ஏற்கனவே வெளியிடப்பட்டுள்ள வழிகாட்டு முறைகளில் திருத்தங்கள் மேற்கொண்டு தருமாறு ஆதிதிராவிடர் நல இயக்குநர் அரசை கேட்டுக்கொண்டுள்ளார்.

ANNEXURE**Guidelines for Overseas Scholarship scheme****I. Objective**

The objective of the scheme is to assist Scheduled Castes / Scheduled Tribes / Scheduled Caste Converted Christian students to pursue Master level courses and Ph.D. Courses in foreign Institutions / Universities as accredited by the Government / authorized body of that country in following courses by providing scholarship.

- a) Engineering and management,
- b) Pure Science and Applied Science,
- c) Agricultural science and Medicine,
- d) International Commerce, Economic, Accounting Finance,
- e) Humanities, Social Science, Fine Arts and Law

II. Eligibility

Candidates must have obtained offer letter from foreign Universities / Institutions that are ranked within the overall Global ranking 1000 published in latest QS (Quacquarelli Symonds) ranking.

III. Age limit

Not more than 35 years of age on first day of April for the selection year for the PG Courses.

Not more than 40 years of age on first day of April for the selection year for the Ph.D. / Research Courses.

IV. Income Ceiling

There shall be two slabs of annual family Income as described below:

Slab-1:

Total family income from all sources not exceeding Rs.8.00 lakhs per annum

Slab-2:

Total family income from all sources above Rs.8.00 lakhs and not exceeding Rs.12.00 lakhs per annum

- Income Certificate should be obtained from the competent authority, Zonal Deputy Thasildar of the State Government.

V. Financial Assistance

Scholarship will consist of two components:

Component-1: Tuition Fees payable by the students every year

Component-2: Living expenses/ Visa fees/ Medical Insurance Premium / Air Fare at the beginning and the end of the course in economy class / equipment allowance / Tax as applicable.

Slab wise calculation of financial assistance:

Slab No.1 (Income up to Rs.8.00 lakhs)

Overall Scholarship of Rs.36.00 lakhs or actual whichever is less will be sanctioned as scholarship. Out of the total sanction, the Tuition fees / component-1 not exceeding 36 lakhs will be released and balance scholarship if any will be adjusted under component-2 as per claim made.

Slab No.2 (Income between Rs. 8.00 lakhs - Rs.12.00 lakhs)

Overall Scholarship of Rs. 24.00 lakhs or actual whichever is less will be sanctioned as scholarship. Out of the total sanction, the Tuition fees / component-1 not exceeding 24 lakhs will be released and balance scholarship if any will be adjusted under component-2 as per claim made.

Illustration:

- If the Tuition Fee is greater than Rs. 36 lakhs (slab-1) / Rs. 24 lakhs (slab-2), Component -1 / Tuition Fees amount up to Rs. 36 lakhs (slab-1) / Rs. 24 lakhs (slab-2) will be released in full. Component-2 will be borne by the students
- If the Tuition Fee is less than Rs. 36 lakhs (slab-1) / Rs. 24 lakhs (slab-2), Component -1 / Tuition Fees in actual will be released. Component-2 will be release based on the actual claims

The Total claim under both the components is limited to Rs. 36 lakhs (slab-1) / Rs. 24 lakhs (slab-2)

- If the candidate has availed any other scholarship, the amount of scholarship will be deducted from the scholarship given under slab 1 and slab 2.

VI. Duration of Course

Post Doctoral Research	1 ½ years
Ph.D.	04 years
Master's Degree	03 years

VII. Mode of disbursal

- a) Tuition Fee / Component-1 fixed by the Institution / University will be credited to the Bank account of the Institution / University abroad as provided by the Institution / University as per their norms.
- b) Component-2 will be credited to the International Bank Account of the Students as provided by the student.
 - In all the cases where the student has paid a part of Tuition Fee / Component-1 as deposit for securing admission, the amount paid by the student will be reimbursed into the student's International Bank account

VIII. Application and Selection Procedures

- a. Scheme will be advertised in the newspaper / website /all other sources and scheme Guidelines are available on the portal <https://www.tn.gov.in/forms/deptname/1>
- b. Eligible candidates can send their application in the prescribed format along with the required documents to the Commissioner/ Director, Adi Dravidar Welfare.
- c. On submission of the letter by the student, the same should be verified with the concerned Institution/ University. The Department will issue a provisional selection letter expressing its intent to sponsor scholarship to the student.
- d. Candidates who are employed, must forward their application through their employer along with No objection certificate
- e. No request for change of Institution/University shall be entertained after securing admission. In case the selected candidate desires to change the course or university, he/she can apply afresh in the next available round.
- f. Selected candidates are required to furnish all such documents i.e VISA, PASSPORT, I-20 / Confirmation of Acceptance of Studies (CAS) etc., before their departure as decided by the Government from time to time.

IX. Other conditions

- a. The candidates are required to make their own efforts in seek admission and join in institutions which have a latest QS ranking up to 1000. Students may be allowed a maximum time period of either one year or two intake deferrals, whichever is earlier from the date of issuance of provisional award letter to join university/Institute abroad. In case confirmation of award letter is issued to an awardee, he/she has to complete all the procedures like verification of original documents, submission of Bonds, etc., before leaving the country for pursuing the course abroad or six months whichever is earlier, failing which the award would stand automatically cancelled.
- b. It will be for the candidate to obtain the appropriate visa for a country wherein he/she intends to study.
- c. The candidate will give an undertaking that he/she will allow his/her university to share information with Government of Tamil Nadu about his/ her academic performance. The candidate has to inform the details of any scholarship received by him/ her.
- d. In case the selected candidate obtains admission in an accredited University/ Institution abroad and joins the University/ Institution before execution of bonds and is not able to return to India then he/ she may execute a Power of Attorney (POA) for any of his/ her representative in India to act for and on his/ her behalf to execute legal Bonds/ agreements / Undertakings with the Government of Tamil Nadu. All such applicants are required to get the POA attested /validated by Indian Embassy/ High Commission in the country where he / she is pursuing studies.
- e. The selected candidates are required to furnish all such documents and enter into such agreements before their departure as shall be decided by the Government of Tamil Nadu from time to time
- f. The Candidates shall not change the University / Institutions or Course of study or research for which scholarship has been sanctioned. If under extraordinary circumstance, if the change is required, then it shall be left to the decision of Government.
- g. The awardee cannot be considered for the award for second or subsequent times as the individual can be awarded only once.

- h. The Institution / University / Individual should submit the Course completion certificate issued by concerned University and placement / Job related information to the Commissioner / Director, Adi Dravidar Welfare.
- i. Every year the Commissioner/ Director, Adi Dravidar Welfare obtain academic performance of the individual from the Institute / University

X. Default under the Scheme

In case a student pursuing studies abroad violates any of the terms and conditions mentioned below will be treated as a defaulter:

- a) Furnishing of false information for getting the scholarship
- b) Indulging in unlawful activities
- c) Institution debar such candidate for any misconduct
- d) Discontinuation of studies without any substantial reasons

On default, he / she will become liable to refund of entire amount spent on him/her along with the interest which will be 12% per annum and in case an awardee fails to repay the amount within six months from the date on which a demand for such refund is made, penal interest at the rate which is 2.5% higher than the above normal rate of interest on the outstanding amount would be charged and he is liable to pay the entire amount failing which the District Collector of the concerned district will realize the amount as arrears under Revenue recovery Act. A personal surity to this effect has to be submitted by the student.

- (iv) Personal surety to be furnished by the students. Specimen copy of Personal Surety & Undertaking will be issued along with confirmation of award letter for doing needful. Undertaking is to be submitted in Rs.10/- non-Judicial stamp paper, sworn in before to Notary public.

After selection process the candidates are required to submit the original documents as sought by the Directorate / Commissionerate of Adi Dravidar Welfare. Candidates are required to visit the Commissionerate / Directorate of Adi Dravidar Welfare personally on any

working day by taking prior permission/ appointment with all documents submitted along with application form in original for verification purposes.

C. The Confirmation of scholarship will be issued on the candidate furnishing the following documents:

- Personal surety to be furnished by the students. Specimen copy of Personal Surety & Undertaking will be issued along with confirmation of award letter for doing needful. Undertaking is to be submitted in Rs.10/- non-Judicial stamp paper, sworn in before to Notary public.
- Two copies of Passport and VISA of the candidate
- An undertaking/declaration on Non-judicial Stamp paper stating that awardee has not acquired the qualification for which he/she has been selected and has not obtained any other scholarship for this purpose which should be certified by the concerned institutions.
- The probable date on which the awardee is desired to undertake the Air journey for joining at the foreign university.
- PDF of all aforesaid documents via email.

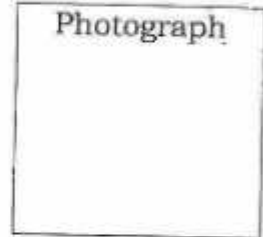
