#### ORDER :

With a view to ensuring audit of all Co-operative Societies independent of the Co-operative Department, the Government in the orders read above, have ordered the creation of a separate Department of Co-operative Audit called the Department of Co-operative Audit headed by a Director of Co-operative Audit. The Department was placed under the control of the Finance Department of the Secretariat. In the Government Order third read above, orders have been issued for creation of a post of Director of Co-operative Audit in the Senior Scale I.A.S., cadre. In the Government Order fourth read above, the Director of Co-operative Audit was empowered to exercise all the powers of a head of department. In the Government order fifth read above, orders have been issued sanctioning creation of the post of Director of Co-operative Audit in the grade of Non-I.A.S., Deputy Secretary to Government, Finance Department in lieu of the post of Director of Co-operative Audit in the Senior Scale I.A.S., cadre. In the Government letter sixth read above, orders have been issued upgrading the post of Director of Co-operative Audit granting higher pay scales. In the Government order seventh read above, one of the Deputy Secretaries to Government, Finance Department was promoted to the upgraded post of Director of Co-operative Audit.

2. The Directorate of Co-operative Audit started functioning with effect from 17.06.1981. The post of Director of Co-operative Audit was held by I.A.S., Officers upto 01.11.1983. From 02.11.1983 to 08.08.1985 the post was held by the Officers in the cadre of Deputy Secretary to Government, Finance Department. From 09.08.1985 the upgraded post of Director of Co-operative Audit is being held by a Deputy Secretary to Government, Finance Department appointed on promotion. The Office of the Director of Co-operative Audit is likely to continue for some more years to come and hence the post of Director of Co-operative Audit would also continue. It is therefore considered necessary to frame adhoc rules for the post of the Director of Co-operative Audit. The Government accordingly frame adhoc rules for the post of Director of Co-operative Audit in the Department of Co-operative Audit, Madras.

3. The following Notification will be published in the Tamil Nadu Government Gazette :-

#### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

The rules hereby made shall be deemed to have come into force on the 2<sup>nd</sup> November 1983.

#### RULES

The General and the Special Rules applicable to the holders of the permanent posts in the Tamil Nadu Co-operative Service shall apply to the holder of the temporary post of Director of Co-operative Audit in the Office of the Co-operative Audit Department sanctioned from time to time, subject to the modifications specified in the following Rules :-

2. Constitution : The post shall constitute a Separate category in the said service.

3. APPOINTMENT : Appointment to the post shall be made by ----

- i) Recruitment by transfer from among the holders of the post of Additional Secretary to Government, Finance Department in the Tamil Nadu General Service" or (G.O.Ms.No.574 Finance (CA) Department, Dt.12.12.2000)
- ii) Promotion from among the holders of the post of Joint Director of Co-operative Audit in the Tamil Nadu Cooperative Service

3A. Qualification:- No person shall be eligible for appointment to the post by promotion unless he has put in a service of not less than three years in the post of Joint Director of Co-operative Audit.

4. Pay : There shall be paid to the holder of the post of monthly pay calculated in the scale of Rs.1300-75-1900-100-2000 with a special pay of Rs.200/- per month

Provided that with effect on and from the 1<sup>st</sup> October. 1984 the monthly pay shall be calculated in the scale of Rs.2150-110-2590-125-3090 with a special pay of Rs.200/- per month.

“Provided further that with effect on and from the 9<sup>th</sup> August 1985 the monthly pay shall be calculated in the scale of Rs.2500-125-3375 “

“Provided also that with effect on and from the 01.01.1996, the monthly pay shall be calculated in the scale of Rs.5100-150-5700”.

“Provided also that with effect on and from the 01.01.1996, the monthly pay shall be calculated in the scale of Rs.16400-450-20000.”

Provided further that in respect of an officer of the Indian Audit and Accounts Service or the Indian Railway Accounts Service or Indian Defence Accounts Service, the monthly pay shall be calculated with reference to the pay fixed by the Government of India from time to time, for the post from which he was appointed by agreement.
