- 2. Constitution: The posts shall form a temporary addition to the category of Superintendents/Section Officers of the said service.
- 3. Appointing authority: The appointing authority for the posts shall be the Secretary to Government, Finance Department.

II. SUPERVISOR GRADE I

RULES

The General and Special Rules applicable to the holders of the permanent posts in category 3 of the Tamil Nadu Treasury and Accounts Subordinate Service shall apply to the holders of the temporary post of Supervisors Grade I sanctioned from time to time for the office of the Government Data Centre Directorate, Madras subject to the modifications specified in the following rules:

- 5. Qualifications: No person shall be eligible for appointment to the post by the methods specified in column (1) of the table below unless he possesses the qualifications specified in the corresponding entries in column (2) thereof:
