APPENDIX

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Madras hereby makes the following rules:-

The rules hereby made shall be deemed to have come into force on the 9th March 1962.

Rules

The General Rules applicable to the holders of the permanent posts in the Madras General Subordinate Service, shall apply to the holder of the temporary post of Artist-Grade I sanctioned in G.O.Ms.No.352 (Lab) Industries, Labour and Cooperation dated 18th January, 1962, subject to the modifications specified in the following rules. (G.O.Ms.No.184, Labour and Employment dated 10.6.1991).

- 2.<u>CONSTITUTION:</u> The post shall constitute a separate category in a distinct class of the said service.
- 3.APPOINTMENT: Appointment to the post shall be made by direct recruitment.
- 4.<u>APPOINTING AUTHORITY</u>: The appointing authority for the post shall be the Joint Director of Employment, Madras.
- 5. <u>QUALIFICATIONS</u>: No person shall be eligible for appointment to the post unless he possesses the following qualifications namely:
 - i. Must have passed atleast III form, preference will be given to candidates with higher educational qualifications other things being equal;
 - ii. Must possess a diploma in fine arts including drawing, commercial art and painting, issued by the Madras Board of Technical Examinations or any other institutions recognized by the University grants Commission for the purpose of its grants other things being equal. Preference shall be given to persons with higher educational qualifications and practical experience in the field. Knowledge of photography shall be an additional qualification (G.O.Ms.No.286, Labour and Employment dated 12.3.82).
- 6.AGE:- No person shall be eligible for appointment to the post if he has completed or will complete 30 years of age of the 1st day of July of the year in which the selection for appointment is made.
- 7.Probation: Every person appointed to the post shall from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.
- 8.PAY: There shall be paid to the holder of the post a fixed monthly pay of Rs.125/-. Provided that on and from the 2nd October 1970 the monthly pay shall be calculated in the scale of Rs.250-10-400/-.

Provided further that on and from the 1st April 19 the monthly pay shall be calculated in the scale of Rs.400-15-490-20-650-25-700.
