In the G.O. cited, the Government directed that one advance increment in the scale of pay applicable to the Government Servants should be sanctioned for their passing the Account Test Examination land that this concession would apply only to the non-gazetted Government servants ;in the "Ministerial Service." The Accountant General Madras and the head of departments have raised certain points for clarification. The following instructions are issued by way of clarification.

- i. The advance increment should be allowed to regular members of the Madras Ministerial Service and not to those appointed under the emergency provisions of the Service Rules, who pass the account Test for subordinate Officers Part I.
- ii. The advance increment should be allowed for passing of the Account Test Part I for the sub-ordinate officers only and not to other Account Tests i.e. Part II for subordinate officers and the Account Test for Executive Officers etc.
- iii. The advance increment should be allowed from the day following the last day of the test.
- iv. When the Account Test in prescribed to be passed within the period of probation in the service rules, the advance increment granted to probationers for passing the Test will not be brought within the purview of Fundamental Rule 31-A. Necessary Amendment to the Fundamental Rules will be issued separately.
- v. When other tests are prescribed in addition to the Account Test in the Service rules the advance increment should be allowed on passing the Account Test alone.
- vi. Where the Account Test is knot prescribed as a condition of probation, the advance increment should be allowed from the day following the last day of the test irrespective of whether the test is passed within or after the period of probation. Amendments to Fundamental Rules will be issued separately.
- vii. The grant of advance increment might result in a Junior Drawing more than pay than his senior. If the senior is compensated it might result in his drawing more pay than his senior and it will create a chain reaction.

viii. The advance increment to Government Servant of passing the Account Test may be sanctioned by the authority which normally sanctioned increment to the Government Servant. Necessary amendments to the Fundamental Rules will be issued separately.

There are other occasions where the senior may happen to draw a lesser pay. The Government therefore consider that the senior need not be compensated in cases where the grant of advance increment results in a Junior Drawing More pay then his senior.

- ix. The advance increment will be admissible for passing the Account Test even when it is prescribed as qualification for promotion to the higher post, though it is not of crucial importance in the case of lower post.

It was represented to the One Man Committee constituted in the Government Order cited, by the Departmental Drivers' Association that the scales of pay recommended by the Second Pay Commission to the Heavy Duty and Light Duty Drivers are only of 16 years duration and hence many who have put in several years of service will stagnate at the maximum of the scales without any promotion. The Association therefore requested that their scales of pay may be revised or Selection Grade posts may be created for them. The Committee after examining the case in detail has recommended that Selection Grade posts of drivers be created on the scales noted against each.

Selection Grade Driver for Heavy Duty Vehicles. Rs.190 –5-255-10-285

Selection Grade Driver for Light Duty Vehicles. Rs.180-5-260-10-270

The Committee has also recommended that general rules of assessment with reference to the number of years of service and merit may be prescribed before Selection Grade Is conferred.

2. The Government examined the recommendations of the One Man Committee and have decided to accept them. They accordingly direct that Selection Grade posts of Drivers for Heavy Duty and Light Duty Vehicles be created on the scales of pay recommended by the Committee referred to in paragraph (1) of these orders. The Government also direct that for the purpose of assessment, a service of 15 years as driver in the respective grade be prescribed as minimum necessary for consideration to the Selection Grade. # ORDER;

The posts of Junior Assistant and Telephone Operator in the TamilNadu Ministerial Service carry the same Scale of Pay viz. 210 - 5 - 245 - 10 - 325. As qualification for the two posts is also same, viz. minimum general educational qualification. An approved probationer in the category of Telephone Operator is eligible for appointment by transfer as Typist as Steno-Typist and vice versa. There is no other provision in the Tamil Nadu Ministerial Service either for conversion as Junior Assistant or for promotion from the post of Telephone Operator. It has been represented to Government that Telephone Operators possessing minimum general educational qualification and other prescribed qualifications may also be made eligible for conversion as Junior Assistant since they have no prospect except for conversion as Typist or Steno-Typist.

2. The Tamil Nadu public Service Commission which was consulted in the matter has proposed the following suggestions for acceptance by Government.

Direct promotion of a Telephone Operator or an Assistant is not appropriate or desirable in the interests of the service Rule 4 of the Tamil Nadu Ministerial Service may be modified suitably so that Telephone Operator may not be considered for director promotion as Assistant.

Since minimum general educational qualification has been prescribed for appointment to the post of Telephone operator as in the case of Junior Assistant, the Telephone Operator may also be made eligible for appointment by transfer to the post of Assistant after a minimum service of atleast 3 years in the Category of Telephone Operator in order to ensure promotional opportunity for those recruited as Telephone Operators. Rule 9 of the Tamil Nadu Ministerial Service may be amended accordingly.

The Technical Qualification has been prescribed for the post of Telephone Operator. Candidates for appointment as Telephone operator s may be required to possess a certificate issued by the Telephone Department or from the Principal of the Telephone Institute recognized by the Government for having undergone the necessary course of Training in the operation of a telephone board. The rules may be amended suitably prescribing such trainings as a necessary qualification for appointment to the post of Telephone Operator in addition to the minimum general educational qualification.

Recruitment to the post of Telephone Operator from among persons who have undergone training may be made through the Commission of the basis of an oral test in the shape of an interview. The orders issued in G.O.Ms.No.106, Public (Services), Dated:-11.01.1945 to the effect that appointment to the post of Telephone Operator might be made without reference to the Commission may be cancelled. The post may be classified as "Technical" for the purpose of direct recruitment. Necessary amendments to G.O.Ms.No.1577, Public (Services), Dated:-16.07.1962 may also be issued.

The Government pass the following orders:-

- 1) The direct recruitment to the post of Telephone Operators in the Tamil Nadu Ministerial Service shall continue to be made through the Employment Exchange.
- 2) The candidates for appointment as Telephone Operators must possess as certificate issued by the Telephone Department or from the Principal of Telephone Institute recognized by the Government for having undergone

- necessary course of Training in the operations of telephone board in addition to the minimum general educational qualification.
- 3) The Telephone Operators who have put in a minimum service of three years in that category are eligible for appointment by transfer to the post of Junior Assistants.
- 4) The Telephone Operators are not eligible for direct promotion as Assistants.
- 5) Amendments to the special rules for Tamil Nadu Ministerial Service will be issued separately.
