### ORDER:

The Government have sanctioned a temporary post of Assistant Librarian in the. scale of pay of Rs.525-25-675-30-855-35-925 to work in Secretariat Library (Reference and Research Wing). The Govt direct that the temporary post of Assistant Librarian be classified as Technical for the purpose of direct recruitment by the Tamil Nadu Public Service Commission.

2. The following notification will be published in the Tamil Nadu Government Gazette:-

#### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules .

2. The rules hereby made shall be deemed to have come into force on and from the 9<sup>th</sup> July 1979.

#### RULES

The General and Special rules applicable to the holders of the permanent post of Assistant Section Officers in the Tamil Nadu Secretariat Service shall apply to the holder of the temporary post of Assistant Librarian (Reference and Research Wing) from time to time sanctioned for the Secretariat Library in the Public Department, subject to the modifications specified in the following rules.

- 2. <u>CONSTITUTION</u>: The post shall constitute a distinct category in the said Service.
- 3. APPOINTMENT: Appointment to the post shall be made as follows:
  - (i) by transfer from the category of Technical Assistant in the Secretariat Library in the Tamil Nadu Secretariat Service; or

- (ii) by promotion from the category of Assistant Section Officer in the Tamil Nadu Secretariat Service; or
- (iii) by direct recruitment; or
- (iv) by recruitment by transfer from any other Service.
- 4. <u>APPOINTING AUTHORITY</u>: The appointing authority for the post shall be the Joint Secretary to Government, Public Department.
- 5. QUALIFICATION: (a) Age: No person shall be eligible for appointment to the post, by direct recruitment, if he has completed or will complete thirty years of age on the first day of July of the year in which the selection for appointment is made.
  - (b) Other qualifications: No person shall be eligible for appointment to the post unless he possess the following qualification, namely:-
  - (i) a degree;
  - (ii) a degree in Library Science or Library and Information Science

6.<u>PROBATION</u>:- Every person appointed to the post of Assistant Librarian by direct recruitment shall, from the date on which one joins duty, be on probation for a total period of two years on duty, within a continuous period of three years.

"Provided that every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty, be on probation for a total period of one year on duty, within a continuous period of two years."

7.<u>PAY</u>:-There shall be paid to the holder of the post a monthly pay calculated in the scale of pay of Rs.525-25-675-30-855-35-925.

"Provided that on and from the 1st October 1984, the monthly pay shall be calculated in the scale of Rs.905-45-1445-50-1545."

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Rules published with the Public Department, Notification No. SRO B-447/80, dated the 8th August 1980, at page 489 of Part-III Section 1 of the Tamil Nadu Government Gazette, dated. the 10th September 1980.

- (i) Amendment (1) hereby made shall be deemed to have come into force on the 30th November 1984.
- (ii) Amendments (2) (3) and (4) hereby made shall come into force on the 30th November 1984.
- (iii) Amendment (5) hereby made shall be deemed to have come into force on the 1st October 1984.

#### AMENDMENTS

In the said Rules, -

- (1) in rule 1, for the expression "Assistants", the expression "Assistant Section Officers" shall be substituted;
- (2) for rule 3, the following rule shall be substituted, namely :-

- "3. Appointment . Appointment to the post shall be made
  - (i) by transfer from the category of Technical Assistant in the Secretariat Library in the Tamil Nadu Secretariat Service; or
  - (ii) by promotion from the category of Assistant Section Officer in the Tamil Nadu Secretariat Service; or
  - (iii) by direct recruitment; or
  - (iv) by recruitment by transfer from any other service";
- (3) in rule 5, in sub-rule (b) for clause (ii), the following clause shall be substituted, namely:-
  - "(ii) a degree in Library Science or Library and Information Science";
- (4) to rule 6, the following proviso shall be added, namely:"Provided that every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty, be on probation for a total period of one year on duty within a continuous period of two years";
- (5) to rule 7, the following proviso shall ,be added, namely :"Provided that on and from the 1st October 1984, the monthly pay shall be calculated in the scale of Rs.905-45-1445-50-1545".
