#### ORDER:

The Government in the G.O. read above, sanctioned as accorded for the conversion of 21 posts of Assistants in Public (CDB) Department, as Despatch Assistants in the pre-revised scale of pay of Rs.975-25-1150-30-1660. It was also ordered therein that the posts of Despatch Assistants shall be filled up by transfer from the post of Record Assistants, pending framing of adhoc rules for the post.

- 2. In the G.O. second read above, the Adhoc Rules for the post of Despatch Assistants have been framed.
- 3. In the G.O. third and fourth read above, orders have been issued that Central Despatch Branch under the control of Public Department be decentralised and the concerned administrative departments be made responsible for their dispatch work. It has also been ordered therein that 21 posts of Despatch Assistants, 1 post of Record Assistant, 3 post of Record Clerks and 3 posts of Office Assistants in Public (CDB) Department, be transferred to various Departments of Secretariat including the Public Department.

### ORDER:

The Government in the G.O. read above, sanctioned has been accorded for the conversion of 21 posts of Assistants in Public (CDB) Department as <u>'Despatch Assistants'</u> in the scale of pay of Rs.975-25-1150-30-1660. It has also been ordered therein that the posts of Despatch Assistants shall be filled up by appointment by transfer of Record Assistants.

2. The following Notification will be published in the <u>Tamil Nadu Government</u> Gazette:-

### <u>NOTIFICATION</u>

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

(2) The rules hereby made shall be deemed to have come into force on the 3<sup>rd</sup> June, 1994.

#### **RULES**

The General Rules applicable to the holders of the permanent post of Record Assistant in Class LXXIX of the Tamil Nadu General Subordinate Service shall apply to the holder of the temporary post of Despatch Assistant sanctioned subject to the modifications specified in the following rules –

2. <u>Constitution</u>.-The post shall constitute a separate category in the said class of the said service:

- 3. Appointment.-Appointment to the post shall be made as follows:-
- (i) by transfer from the holders of the post of Record Assistant in the Departments of Secretariat in Class LXXIX of the Tamil Nadu General Subordinated Service; or
- (ii) by promotion from the holders of the post of Record Clerk in the Departments of Secretariat in Class XXII of the Tamil General subordinate Service; or
  - (iii) by recruitment by transfer from any other service.
- 4. <u>Appointing authority</u>.- The appointing authority for the post shall be the Deputy Secretary to Government / Joint Secretary to Government, as the case may be, who is dealing with the Establishment matters in the Public Department.
- 5. <u>Qualification</u>.- No person shall be eligible for appointment to the post by promotion unless he has completed ten years of service in the post of Record Clerk in the departments of Secretariat.
- 6. <u>Probation</u>.- Every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty, be on probation for a total period of one year on duty, within a continuous period of two years.
- 7. Pay.- There shall be paid to the holder of the post a monthly pay calculated in the scale of pay of Rs.975-25-1150-30-1660.
