ORDER:

The Government in the G.O. read above, sanctioned two temporary posts of Library Assistants in the revised scale of pay of V Pay Commission (Rs.1200-30-1560-40-2040) to attend to the classification and cataloguing works in the Secretariat Library. The Government direct that the temporary posts of Library Assistants be classified as Technical for the purpose of direct recruitment by the Tamil Nadu Public Service Commission.

2. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The rules hereby made shall be deemed to have come into force on the 21st December 1987.

RULES

The general and the special rules applicable to the holders of the permanent posts of Assistant in the Tamil Nadu Secretariat Service shall apply to the holder of the temporary post of Library Assistant sanctioned from time to time for the Secretariat Library in the Public Department, subject to the modifications specified in the following rules –

2. Constitution.-The post shall constitute a distinct category in the said service ;
3. Appointment.-Appointment to the post shall be made –
 - (i) by direct recruitment ; or
 - (ii) by promotion from the post of Assistant / Typist including Personal Clerks and Tamil Typists in Tamil Nadu Secretariat Service ; or
 - (iii) by recruitment by transfer from any other service.
4. Appointing authority.-The appointing authority for the post shall be the Deputy Secretary to Government / Joint Secretary to Government, as the case may be, of the Public Department.
5. Qualification.-
 - (a) Age.- No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete thirty years of age on the first day of July of the year in which the selection for appointment is made.
 - (b) Other qualifications.-No person shall be eligible for appointment to the post unless he possesses the following qualifications, namely:-
 - (i) A degree; and
 - (ii) A Certificate in Library Science.
6. Probation.- Every person appointed to the post by direct recruitment shall, from the date on which he joins duty, be on probation for a total period of two years on duty, within a continuous period of three years.

Provided that every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty, be on probation for a total period of one year on duty, within a continuous period of two years.

7. Pay.- There shall be paid to the holder of the post a monthly pay calculated in the scale of pay of Rs.1200-30-1560-40-2040.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Rules published with the Public department Notification No. SRO B-430/89, dated the 10th November 1989, at pages 281-282 of part II Section 1(b) of the Tamil Nadu Government Gazette, dated the 29th November 1989.

AMENDMENT

In the said Rules, in rule 5, for sub-rule (b), the following sub-rule shall be substituted, namely:-

“(b) Other qualifications- No person shall be eligible for appointment to the post unless he possesses the following qualifications, namely:-

- (i) a degree; and
- (ii) a degree in Library Science or in Library and Information Science”.
