ORDER:

In the G.O. read above, orders were issued for the creation of one Temporary Post of Head Record Assistant for supervising the Record Assistants in the Public (CRB) Department, for which the following Ad-hoc Rules are issued.

2. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The rules hereby made shall be deemed to have come into force on the 1st February 1988.

<u>RULES</u>

The General Rules and the Special Rules applicable to the holders of the permanent post of Record Assistant in the Public Department of the Tamil Nadu Secretariat in Class LXXIX of the Tamil Nadu General Subordinate Service shall apply to the holder of the temporary post of Head Record Assistant in the Public Department of the Tamil Nadu Secretariat, subject to the modifications specified in the following rules:-

2. Constitution:- The post shall constitute a separate category in the said class of the said service.

- 3. Appointment:- Appointment to the post shall be made by promotion from among the holders of the post of Record Assistants in the Public Department of the Tamil Nadu Secretariat. No person shall be eligible for appointment to the post, unless he has completed five years of service in the post of Record Assistant in Public Department.
- 4. Appointing Authority:- The Appointing authority for the post shall be the Under Secretary to Government, who is in charge of the establishment matters relating to Record Assistants in Public Department.
- 5. Pay:- There shall be paid to the holder of the post, a monthly pay calculation of the scale of Rs.705-20-745-25-845-35-1230

Provided that with effect on and from the 1st June 1988, the scale of pay shall beRs.1200-30-1560-40-2040.

Provided further that with effect on and from the 1st January 1996, the scale of pay shall be Rs.4000-100-6000.
