#### ORDER:

In the G.O.third read above, orders were issued for the formation of a separate Directorate of Ex-servicemen's Welfare by merging the office of the Tamil Nadu Soldiers', Sailors' and Airmen's Board and the office of the Amalgamated Funds. The Post of Secretary, Tamil Nadu Soldiers', Sailors' and Airmen's Board was redesigated as Joint Director of Ex-Servicemen's Welfare and the Secretary, Amalgamated Funds as Deputy Director of Ex-servicemen's Welfare. No amendments have so for been issued to the adhoc rules governing the posts of Secretary, Tamil Nadu Soldiers', Sailors' and Airmen's Board and the Secretary, Tamil Nadu Soldiers', Sailors' and Airmen's Board and the Secretary, Tamil Nadu Soldiers', Sailors' and Airmen's Board and the Secretary, Tamil Nadu Soldiers', Sailors' and Airmen's Board and the Secretary, Tamil Nadu Soldiers', Sailors' and Airmen's Board and the Secretary, Tamil Nadu Soldiers', Sailors' and Airmen's Board and the Secretary, Tamil Nadu Soldiers', Sailors' and Airmen's Board and the Secretary, Tamil Nadu Soldiers', Sailors' and Airmen's Board and the Secretary, Amalgamated Funds. The posts of Deputy Director and Joint Director have already been made permanent in the G.O.s. fourth and fifth read above. In the G.O. sixth read above, orders keeping the posts of Assistant

Director and Deputy Director outside the purview of the Tamil Nadu Public Service Commission were issued. Consequently the method of recruitment to the Assistant Director, Deputy Director and Joint Director and the qualification therefor were also issued in the G.O. seventh read above. The Government have, therefore, decided to issue special rules to the post of Joint Director, Deputy Director and Assistant Director incorporating the provisions in the adhoc rules with modification regarding the method of recruitment and qualification therefor for direct recruitment prescribed in the G.O seventh read above.

2. The post of Secretary to the Committee for the administration of Amalgamated Tamil Nadu Shares of the Post War Services Reconstruction Fund and the Special Fund for Reconstruction and Rehabilitation of Ex-Servicemen is governed by separate adhoc rules. The post was redesignated as Deputy Director when the Directorate of Ex-servicemen's Welfare was formed. No amendment has been issued consequent on the redesignation. In the G.O. ninth read above, the post of Deputy Director was redesignated as Joint Director. The Government, therefore, direct that the two posts of Joint Directors in the Directorate of Ex-servicemen's Welfare be treated as common category.

Category 3: Assistant Director of Ex-servicemen's Welfare Provided that on and from the 11<sup>th</sup> May 1979, this service shall consists of the following categories of posts, namely:-

Category 1: Joint Director of Ex-servicemen's Welfare. Category 2: Assistant Director of Ex-servicemen's Welfare.

2. <u>Appointment :</u>- Appointment to the categories of posts specified in column (1) of the Table below shall be made by the methods specified in the corresponding entries in column (2) thereof:-

- (ii) By recruitment by transfer from any other service.

3. <u>Appointing Authority:-</u> The appointing authority for the post shall be the Director of Ex-Servicemen's Welfare, Madras.

4. <u>Qualification:-</u> No person shall be eligible for appointment to the post by the methods specified in column (1) of the Table below, unless he possesses the qualification specified in the corresponding entries in column (2) there.

## THE TABLE

# Method of appointment

#### **Qualification**

- (a) Direct recruitment : (i) Must have passed III form of VIII Standard, provided that the educational qualification shall not be insisted in the Ex-Servicemen.
  - Must possess a current driver licence of a motor vehicle issued by a competent authority under the Motor Vehicles Act 1939,

with practical experience of driving a motor vehicle for a period of not less than five years.

- (iii) Must not have completed 40 years. Provided that among other things being equal preference shall be given to the Ex-Service Personnel of the Armed Forces drawing military pension –
- (iv) (a) In the case of Ex-Servicemen not belonging to SC/ST and BC they should not have completed 48 years of age.
  - (b) In the case of Ex-Servicemen belonging to SC/ST and BC they should not have completed 53 years of age.
- (v) The above rules (iv) (a) & (b) shall come into force with effect from 22.09.1981.
- (b) By recruitment by Must have served as Last Grade transfer Government servant in the Directorate of Ex-Servicemen's Welfare or in any other office of the State Government for not less than five years and possess a current driving licence of a motor vehicle issued by the competent authority under the Motor Vehicles Act 1939 with practical experience of driving a motor vehicle for a period of not less than five years.

5. <u>Probation:-</u> Every person appointed to this class by direct recruitment shall be on probation for a total period of two years on duty with a continuous period of three years, provided that in the case of persons appointed by recruitment by transfer the period of probation shall be for one year within a continuous period of two years.

In the G.O third read above, the Special Rules governing the post of Driver in the Department of Ex-servicemen's Welfare were issued inserting a new class namely Class LXXX in the Tamil Nadu General Subordinate Service. In Rule 3 of the said special rules, it has been indicated that the Director of Ex-servicemen's Welfare, Madres shall be the appointing authority. In the G.O. first read above, the Joint Director of Ex-servicemen's Welfare, was vested with the powers of appointments, transfers, posting of Assistants, Welfare Workers, Accountants, Junior Assistants, Steno-typists, Typists, Record Clerks and Drivers. However at the time of issue of Special Rules, governing the post of Driver, the post of Joint Director was kept in abeyance and as such the Director has been mentioned as the appointing authority. Since the post of Joint Director has been revived, the Joint Director, Ex-servicemen's Welfare has sent proposals for amending the rule relating to the appointing authority indicating the Joint Director as appointing authority.

2. In the said Special Rules in Rule 4(b) relating to the method of recruitment by transfer, not less than five years service has been prescribed for the appointment of a Last Grade Government servant to the post of Driver. In G.O. Rt. No. 1077, Personnel and Administrative Reforms, dated 1.12.1987, it has been ordered, that the Office Assistants

shall be promoted by transfer after completion of one year of service. Hence, the Joint Director, Ex-servicemen's Welfare has suggested amendment to this Rule also reducing the period of service from five years to one year.

3. The Government after careful consideration accept the proposals of the Joint Director of Ex-Servicemen's Welfare in paragraphs 1 and 2 above.
