The Director of Social Welfare, in her letter twenty-fifth read above, has sent proposals for issue of consolidated set of adhoc rules for the posts of Deputy Directors, Assistant Directors, Superintendent of Sheltered Workshop, Special Officer (Bunk Stall) Child Development Project Officers and Taluk Project Nutrition Officers for the following reasons:-
- (i) For grouping and categorizing all posts in the identical scale of pay;
- (ii) To have adhoc rules for the posts for which the nomenclature have been changed;
- (iii) Up-gradation of the posts of District Social Welfare Officers; and
- (iv) Modifications to the existing rules to suit the present requirements.
- 5. The Government accept the proposals of the Director of Social Welfare.

- 4. Qualification- (a) Age- No person shall be eligible for appointment to the posts of Assistant Directors/District Social Welfare Officers/District Project Nutrition Officers/Regional Rehabilitation Officers/Child Development Project Officers/Taluk Project Nutrition Officers/Special Officer (Bunk Stall) and Superintendent, Sheltered Workshop for the Blind by direct recruitment, if he has completed or will complete 28 years of age on the 1st day of July of the year in which the selection for appointment is made.
- (c) Other qualifications- No person shall be eligible for appointment to the posts specified in column(1) of the Table below by the method of appointment specified in column (2) unless he possesses the qualifications specified in the corresponding entries in column (3) thereof:-

5. Reservation of appointment- The rule relating to reservation of appointment (General Rule 22) shall apply for appointment to the posts of Assistant Directors, District Social Welfare Officers, Child Development Project Officers and Taluk Project Nutrition Officers by direct recruitment.

6. Sex- Women alone shall be eligible for appointment to the post of District Social Welfare Officer, Child Development Project Officer, Taluk Project Nutrition Officer and Superintendent, Sheltered Workshop for the Blind

7. Probation-Every person appointed to the posts by direct recruitment shall, from the date on which she joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

Provided that every person appointed to the post by recruitment by transfer shall, from the date on which she joins duty, be on probation for a total period of one years on duty within a continuous period of two years.

8. Tests:- Every person appointed to the posts by direct recruitment shall within the period of her probation pass the following Tests, namely:-

- (i) District Officer Manual Test;
- (ii) Account Test for Subordinate Officers, Parts I and II or Account Test for Executive Officers:

Provided that every person appointed to the posts by recruitment by transfer shall pass the above Tests within a period of two years. Penalty for failure to pass the said Tests shall be stoppage of increment without cumulative effect until they pass the Tests.

9. Preparation of Annual List of Approved Candidates:- For the purpose of preparation of the annual list of approved candidates for appointment to the posts by promotion and by recruitment by transfer, the crucial date on which the candidates shall have acquired the prescribed qualifications shall be the 1st September of the year to which the list relates.

In the Government order third read above, adhoc rules were issued for the post of Administrative Officer (Social Welfare Department) in the cadre of Under Secretary to Government in the Directorate of Social Welfare. As there were no promotional avenues among the male Ministerial Staff beyond Superintendent, the Director of Social Welfare has suggested that instead of creating/ sanctioning a post of Assistant Director, the post of Administrative Officer (Social Welfare Department) may be downgraded to the cadre of Assistant Director and be filled up by recruitment by transfer from among the holders of the post of Superintendents from the Ministerial Service working in the Department of Social Welfare and Nutritious Meal Programme on the basis of seniority.

7)Qualification – Sex – Women alone shall be eligible for appointment to the categories of posts specified in items 1,2,3,5 and 6 in rule 2.

8)Qualification:- No person shall be eligible for appointment to the categories specified in column (1) of the Table below unless she possess the qualifications specified in the corresponding entries in column (2) thereof:-

CATEGORIES	QUALIFICATIONS
(a) District Women's Welfare Officers	By direct recruitment should possess a post –graduate degree in Arts or Science of University or institution recognized by the University Grants Commission for the purpose of its grant.
(b) Superintendent Service Home	By direct recruitment and by promotion should possess post-graduate degree in Arts or Science of any University or institution recognized by the University Grants Commission for the purpose of its grants and should possess a degree or diploma in Teaching recognized by the University Grants Commission for the purpose of its grant.
2) Mukhysasevika	By Direct recruitments:- Must hold a degree of University or institution recognized by the University Grants Commission for the purpose of its grant.
	Note: Candidates with a degree or diploma in Social Work of any University or Institution recognized by the University Grants Commission for the purpose of its grants will be preferred. Recruitment by transfer:-
	For recruitment to the post of Mukhyasevika by transfer from Madras Educational Subordinate Services the qualification may be a Graduate trained teacher with three years experience or a Secondary Grade Trained Teacher with five years experience.
3)Women's Welfare Organizer and Gramasevika	Candidate should possess minimum General Educational Qualification specified in the general rules for the Madras State and Subordinate Services.
4) Sub- Editor	Must hold a B.A. or B.O.L degree in Tamil Literature of a University or institution recognized by the University Grants Commission for the purpose of its grant NOTE: Preference will be given to
	holders of a diploma in Journalism of any University or institution recognized by the University Grants Commission for the purpose of its grant and

	experience in any dailies or journals in India.
5) Matron	Must possess a complete secondary school leaving certificate and must have experience in managing a hostel
6) Junior Matron	- do -
7) Driver	 (i) Must possess a license issued by a competent licensing authority to driver heavy motor transport vehicles and (ii) Must have had previous experience in driving heavy motor vehicles for a period of not less than two years.

9)Probation:- Every person appointed to the categories of posts specified in rule 1 shall, from the date on which she / he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

10)Tests:- Every person appointed to the posts of District Women's Welfare Officer including Superintendent, Service Home, shall within the period of her probation , pass the Account Test for Subordinate Officer, Part I and II or the Account Test for Executive Officers.

11)Training:- Every person selected for appointments to the post of Mudhyasevika shall undergo the prescribed course of training in the Social Education Organizers' Training Centre as and when the Government direct.

12)Agreement:- Every person appointed to the post of Mukhyasevika and Gramasevika shall before undergoing the training execute an indemnity bond in such form and for such form and for such amount as may be prescribed by the State Government from time to time to time binding herself:-

- (i) to undergo the entire course of training;
- (ii) to serve the State Government for a period of not less than three years after the successful completion of training;
- (iii) to abide by any other condition that may be stipulated from time to time by the Director of Women's Welfare; and
- (iv) in case she fails to fulfill any of the conditions mentioned in clauses (i) to (iii) above to forfeit all claims for the pay and allowances and for the payment of further stipends as the case may be and to refund to the State Government the amount drawn by the trainee as pay and allowances in the case of Mukhyasevika and/or stipend in the case of Gramasevika as the case may be, during the course of training, such sum being ordinarily determined with reference to the period by which her service, if any, fall short of the compulsory period.

13)Pay – There shall be paid to the holders of the posts specified in columns (i) of the Table below a monthly pay calculated in the scale of pay specified in the corresponding entry in column (2) thereof:-

ORDER:

Originally the posts of Gramasevikas and Mukhyasevika (Since rerdesignated as Extension Officer (Social Welfare) were governed by the adhoc rules issued in G.O.Ms.No.2462, public (RLP) dated 16.07.56 and the post of Women's Welfare Organiser was governed by the adhoc rules issued in G.O.Ms.No.1627, public (RLP) dated 19.05.55 in supersession of the said adhoc rules, a fresh set of adhoc rules were issued in G.O.Ms.No.1330, R.D.L.A, dated 9.6.65 for various post in the Women's Welfare Department which took effect from 9.6.65.

- 2. Consequent on the issue of the revised set of adhoc rules with effect from 9.6.65 Superseding the adhoc rules issued in G.O.Ms.No.2462, public (RLP) dated 16.7.56 and number of Gramasevikas and Extension Officers (Social Welfare) who were fully qualified for those posts in accordance with the adhoc rules in force on the date of their appointment (i.e. prior to 9.6.65) and in whose casesregularisation orders were not issued prior to 9.6.65 for administrative reasons, could not be regularized form a date prior to 9.6.65 and in some cases therir services could be regularized only after relaxing certain rules in their favour in accordance with the set of adhoc rules. in order to protect the 9nterests of those who were appointed in the Department of Social Welfare prior to 9.6.65 with reference to the adhoc rules then in force, an amendment is felt necessary to the adhoc rules issued in the G.O.Ms.No.1330, RD.L.A., dated 9.6.65 as subsequent amended.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Rules published with the Rural Development and Local Administration Department Notification SR.O. 656 of 1965, dated the 9th June 1965, at page 683 of part V of the Fort St. GEORGE GACETTE dated the 30th June 1965.

AMENDMENT

In the said rules, rule 13 shall be renumbered as rule 14 and before rule 14 as so renumbered, the following rule shall be inserted namely:-

"13. <u>SAVINGS</u>:- Notwithstanding anything contained in these rules or in any other rules which are superseded by these rules, the appointment of any person to any post to which these rules shall apply made before the dated of issue of these rules should be always deemed to have been validly made in accordance with the rules then in force for all purposes whatsoever; and the services of such person shall be regularized with effect form the date of First appointment of such person or such date as the appointing authority may determine."
