New Delhi in the Tamil Nadu Ministerial Service or from any other service.

- (4) in rule 13, for the expression "Assistant Section Officer, Assistant in Law Department "the expression "Assistant Section Officer, Assistant Section Officer (Translations), Assistant Reception Officer, Tamil Nadu House, New Delhi, Assistant in Law Department, Assistant (Translations)" shall be substituted:

ORDER:-

The Government have sanctioned a number of temporary posts in the past few years for the upkeep and maintenance of Tamil Nadu House, New Delhi. Certain posts are on Central scales of pay and certain other posts in the same category are in the State scales of pay. The Government have taken a decision to have two sets of Adhoc rules for governing the service conditions of the posts in Tamil Nadu House, one for the post borne on the Central scales of pay and one for the posts on State scales of pay.

2. The following notification will be published in the Tamil Nadu Government Gazette.

NOTIFICATION - I

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

The Rules hereby made shall be deemed to have come into force on the 31st March 1977.

RULES

The General and Special Rules applicable to the holders of the permanent posts in Category 2 of Class III of the Tamil Nadu Treasury and Accounts Service shall apply to the holder of the temporary post of Senior Accounts Officer in the Tamil Nadu House, New Delhi which is in the Tamil Nadu Government scales of pay.

<u>Constitution</u>:- The post shall form a temporary addition to the said category in the said class of the said service.

<u>3. Pay</u>: There shall be paid to the holder of the post a monthly pay in the scale of Rs.750-50-1350/- with a special pay calculated at 20% of the basic pay.
