### **Special Rules**

LEGAL ADVISER/DEPUTY LEGAL ADVISER/PROSECUTOR FOR DISCIPLINARY PROCEEDINGS

(DIRECTORATE OF VIGILANCE AND ANTICORRUPTION)

(G.O.Ms.No.646, P&AR (PER-N) DEPT, Dated 13.7.1987. with effect from 5th May 1978) In the said Special Rules:-

(1) in Part - I, after class LXXIII and the entries relating thereto, the following class and entries shall be added namely:-

"Class LXXIV Law Officers in the Directorate of Vigilance and Anti-Corruption".

(2) in Part-II, after Class LXXIII and the rules there under, the following Class and rules shall be added, namely:-

"Class LXXIV Law Officers in the Directorate of Vigilance and Anti-Corruption".

1. Constitution: This class shall consist of the following categories of officers, namely:-

Category - 1 - Legal Adviser

Category - 2 - Deputy Legal Adviser

Category - 3 - Prosecutor for Disciplinary Proceedings.

2. Appointment: Appointment to the category specified in column (1) of the Table below shall be made by the methods specified in the corresponding entries in column (2) thereof:-

(iii) Promotion from the category of Deputy Legal Adviser in the Directorate of Vigilance and Anti-Corruption.

### 2. Deputy Legal

Adviser

(i) Promotion from among the holders of the posts of Prosecutors for Disciplinary Proceedings in the Directorate of Vigilance and Anti Corruption and

Assistant Public Prosecutors Grade-I in the Tamil Nadu General Service, or

(ii) Promotion from among the holders of the posts of Legal Advisers to the Deputy Inspector General of Police, Crime Investigation Department, Madras, Commissioner of Police, Madras and Deputy Inspector General of Police, Food Cell, Crime Investigation Department, Madras in Class XLIV of the Tamil Nadu General Service. Provided that the method of appointment (ii) referred to above shall be resorted to only if no qualified and suitable candidates are available by the method of appointment (i) referred to above.

3. Prosecutor for

(i) Transfer from among the holders of the post of Assistant Public

Prosecutor Grade-I.

Proceedings.

or

(ii) Promotion from among the holders of the post of Assistant Public Prosecutor Grade-II.

3.\*Leave

(iii) "The authority competent to grant leave to the Legal Adviser, Deputy Legal Adviser and Prosecutor for Disciplinary Proceedings shall be the Director of Vigilance and Anti-Corruption."
