**NOTIFICATION**

G.S.R.713 (E). - In exercise of the powers conferred by section 43 of the Emigration Act, 1983 (31 of 1983), the Central Government hereby makes the following rules further to amend the Emigration Rules, 1983, namely:-

1. (1) These rules may be called the Emigration (Amendment) Rules, 2002.

(2) They shall come into force with effect from 1st November, 2002.

2. In the Emigration Rules, 1983,

(a) In rule 7, in clause (i), for the words "five hundred rupee" the words "two thousand rupees" shall be substituted.

(b) In Rule 9A, for the words "five hundred rupees" the words "two thousand rupees" shall be substituted.

(c) In rule 11, after sub-rule (2) the following shall be inserted, namely:-

"(3) The application under rules (1) and (2) above shall be accompanied by bank draft of rupees two thousand payable in favour of the Pay and Accounts Officer, Ministry of Labour (Main Secretariat), New Delhi, towards the application fee".

(d) In sub-rule (1) of rule 15, after the words "or through the employer" and before the words "concerned and", the words "including Indian employers permitted under rule 11 (2)" shall be inserted.

(e) In clause (g) of sub-rule (1) of rule 15, for the words " rupees one hundred", the words "rupees two hundred" shall be substituted.

(f) After rule 15, the following rule shall be inserted namely:-

"15A. All applications from the persons, individually or through recruiting agents or through other permitted agents, who intend to go abroad on short term non-employment visit and requiring suspension of emigration check requirements for a limited period (emigration suspension), shall be accompanied by a demand draft of rupees one hundred drawn in favour of the Protector General of Emigrants as fee in respect of each applicant".

(g) In sub-rule (1), of rule 18, for the words: "rupees one hundred", the words " rupees two hundred" shall be substituted.
