## Order:

In the Government Order first read above one temporary post of Archaeological Chemist in the Department of Archaeology was created. In the reference third and fourth read above proposals for framing adhoc Rules for the post of Archaeological Chemist were receive from the Department of Archaeology. The Government after examining the proposal of the Additional Director or Archaeology approve the proposal and for the purpose of direct recruitment the post is classified as Technical and brought under the purview of the Tamilnadu Public Service Commission.

2. The following Notification will be published in the Tamil Nadu Government Gazette.

#### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules.

2. The rules hereby made shall be deemed to have come into force on the 5th September 1979.

#### RULES

The General Rules applicable to the holders of the permanent post in the Tamilnadu General Subordinate Service shall apply to the holder of the temporary post of Archaeological Chemist, sanctioned from time, in the Department of Archaeology, subject to the modifications specified in the following rules. 2. Constitution: The post shall constitute a distinct class in the said service.

3. Appointment: Appointment to the post shall be made

- i) by direct recruitment or
- ii) by transfer from any other class or category; or
- iii) by promotion from the post of Assistant Chemist in the Department of Archaeology; or
- iv) by recruitment by transfer from any other service.

4. Appointing Authority: The appointing authority of the post shall be the Director of Archaeology.

5. Qualifications: a) Age: No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete 30 years of age on the 1st day of July of the year in which the selection for appointment is made.

b) Other Qualifications: No person shall be eligible for appointment to the post by the methods specified in column (1) of the Table below unless he possess the qualifications specified in the corresponding entries in column (2) there of:-

6. Probation: Every person appointed to the post by direct recruitment shall, from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

b) Every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty be on probation for a period of one year on duty within a continuous period of two years.

7. Pay: There shall be paid to the holder of the post a monthly pay calculated in the scale of Rs.600-30-750-35-890-40-1050.

Provided with effect on and from the 1st October 1984, the monthly pay shall be calculated in the scale of Rs.1045-45-1450-65-1775.
