The Tamil Nadu Public Service Commission when consulted on the proposal for excluding the above mentioned posts from its purview suggested that the adhoc rules governing the posts may be issued in the first instance in consultation with the Commission and thereafter it is open to the Government to address the Commission for exclusion of the posts from its purview and the Commission also agreed to the adhoc rules sent to it subsequently.

- 3. The Government accept the suggestion of the Tamil Nadu Public Service Commission and approve of the adhoc rules in the Appendix to this order.
- 4. The non-Gazetted posts of the Translator, Section Officer and Junior Assistant do not fall within the purview of the Commission unless brought within its purview and the Government have decided not to bring the non-Gazetted posts of Translator, Section Officer and Junior Assistant within the purview of the Commission and approve of the adhoc rules for these posts in the Appendix to this order.

2. The rules hereby made shall be deemed to have come into force on the 5th August, 1967.

RULES

The General Rules applicable to the holders of the permanent posts in the Tamil Nadu General Service shall apply to the holder of the temporary post of Member-Secretary, State Official Language (Legislative) Commission, subject to the modifications specified in the following rules:-

- 2. <u>Constitution:</u> The post shall constitute a distinct Class in the said Service.
 - 3. Appointment: Appointment to the post shall be made-

The rules hereby made shall be deemed to have come into force on the 10th December 1984.

RULES

The rules hereby made shall be deemed to have come into force on the 20th December 1974.

The general and the special rules applicable to the holder of the permanent posts of Section Officer in the Tamil Nadu Secretariat Service shall apply to the holder of temporary post of Librarian, sanctioned from time to time, for the Library in the Law Department subject to the modifications specified in the following rules.

- 2. Constitution.—The post shall constitute a distinct category in the said service.
 - 3. Appointment.—The appointment to the post shall be made as follows:--
 - (a) by direct recruitment; or
 - (b) for special reasons, by recruitment by transfer from any other service.

Provided that preference shall be given to a person who, in addition to the above Qualification is an Advocate of the High Court of the State with not less than seven years standing at the Bar.

5. <u>Age</u>. No person shall be eligible for appointment to the post, by direct recruitment, if he has completed or will complete forty five years of age on the first day of July of the year in which the selection for appointment is made.

- 6. <u>Probation</u>:- Every person appointed to the post from the date on which he joins duty, be on probation a total period of one year on duty within a continuous period of two years.
- 7. <u>Pay:</u>- There shall be paid to the holder of the post a fixed pay of Rs.1,500/- per mensem.

NOTIFICATION - III

RULES

The Special Rules applicable to the holders of the permanent posts of District Munsifs in the Tamil Nadu State Judicial Service, shall apply to the holder of the temporary post of Assistant Secretary, State Official Language(Legislative) Commission, subject to the modifications specified in the following rules:-

- 2. <u>Constitution</u>:- The post shall constitute a distinct category in the said Service.
 - 3. <u>Appointment</u>:- Appointment to the post shall be made:- Vide
 - (i) by recruitment by transfer from among the holders of the post of Section Officer in Law Department of the Class XII of Tamil Nadu General Service or Section Officer or Translator in the State Official Language (Legislative) 4-2-91 Commission; or
 - (iii) for special reasons, by direct recruitment.",
- 4. <u>Qualifications:</u>- No person shall be eligible for appointment to the post, by direct recruitment unless he is practicing as an Advocate in any High Court or enrolled as an Advocate in any of the Bar Council of the Indian Union with not less than 3 years standing at the Bar and has not completed 32 years of age on the first day of July of the year in which selection for appointment is made.
- (b) No person shall be eligible for appointment to the post by recruitment by transfer from among the holders of the post of Translators in the State Official Language (Legislative) Commission unless he/she holds a degree in <u>Bachelor of Law"</u>.

- 5. <u>Probation:</u> Every person appointed to the post by direct recruitment or by recruitment by transfer from the holders of the post of Translators in the State Official Language (Legislative) Commission, shall, from the date on which he joins duty, be on probation for a total period of one year on duty within a continuous period of two years."
- 6. <u>Pay:-</u> There shall be paid to the holder, of the post a monthly pay calculated in the scale of Rs.375-25-700-plus a special pay of Rs.100/-.

Provided that on and from the 2nd October, 1970, there shall be paid to the holder of the post, a monthly pay calculated in the scale of Rs.750-40-950-50-1100;

Provided further that the District Munsifs who are appointed to the post shall be paid their grade pay plus a special pay of Rs.100/- per mensem.

NOTIFICATION – IV

In exercise of the powers conferred by the proviso to Article 309 of the constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The rules hereby made shall be deemed to have come into force on the 18th June, 1969.

<u>RULES</u>

The General Rules applicable to the holders of the permanent posts in the Tamil Nadu General Subordinate Service shall apply to the holders of the temporary posts of Translators in the State official Language(Legislative) Commission, subject to the modifications specified in the following rules:-

- 2. <u>Constitution</u>:- The posts shall constitute a distinct Class in the said Service.
 - 3. Appointment: Appointment to the posts shall be made: -
 - (i) by transfer from among the holders of the posts of Translation Superintendents in the Tamil Development and Culture Department of the Secretariat; or
 - (ii) by recruitment by transfer from any other service; or G.O.Ms.No. 117, Law, dt.7.4.1987.
 - (iii) by direct recruitment."

- 4. <u>Appointing authority</u>:- The appointing authority for the posts shall be the Secretary to Government in the Law Department.
- 5. <u>Qualification</u>:- No person shall be eligible for appointment to the post unless he possesses the following qualifications, namely:-
 - (i) must hold the B.A., B.Sc., or B.Com., degree in vide G.O.Ms addition to holding a degree in Law and must have high proficiency in Tamil; or dated 28.5.77
 - (ii) must hold at least a second class Master's degree in Tamil.
- 6. <u>Age</u>:- No person shall be eligible for appointment to the posts, by direct recruitment, if he has completed or will complete forty years of age on the first day of July of the year in which the selection for appointment is made.
- 7. <u>Probation</u>:- (a) Every person appointed to the post, shall, from the date on which the joins duty, be on probation for a total period of one year on duty within a continuous period of two years.
- (b) The Member-Secretary, State Official Language(Legislative) Commission shall be the authority competent to declare the satisfactory completion of probation of a probationer in the post.
- 8. <u>Pay</u>:- There shall be paid to the holders of the posts a fixed pay of Rs.300/- per mensem;

Provided that on and from the 2nd October, 1970, there shall be paid to the holders of the posts, a monthly pay calculated in the scale of Rs.425-25-600-30-750.

9. <u>Leave and Posting</u>:- The Member-Secretary, State Official Language(Legislative) Commission shall be the authority competent to grant leave and to order postings of holders of the posts.

- 2. <u>Constitution</u>:- The post shall constitute a distinct category in the said service.
- 3. <u>Appointment</u>:- Appointment to the post shall be made by transfer from among the holders of the post of Junior Assistant in the Tamil Nadu Secretariat Service.
- 4. <u>Appointing Authority</u>:- The appointing authority for the post shall be the Member-Secretary, State Official Language(Legislative)Commission.
- 5. <u>Probation</u>:- Every person appointed to the post shall from the date on which the joins duty be on probation for a total period of two years on duty within a continuous period of three years.

Provided that a person who is already an approved probationer or full member need not undergo fresh probation.
