## ORDER:

In the G.O. second read above, the Tamil Nadu National Law School Act, 2012 ( Tamil Nadu Act 9 of 2012) was published in an extra - ordinary issue of the Tamil Nadu Government Gazette, dated the 23<sup>rd</sup> February 2012, for establishing the Tamil Nadu National Law School at Srirangam taluk, Trichirapalli district.

2. In the letter read above, the Engineer - in - Chief (Buildings) and Chief Engineer (General) Public Works Department has submitted the rough Cost Estimate for according administrative sanction of the Government for Rs. 7500.00 lakhs for the proposed construction of The Tamil Nadu National Law School at Navalur Kuttapattu Village, Srirangam taluk, Trichirapalli district, covering a total plinth area of 42331.83 m<sup>2</sup>.

3. The Government after careful consideration, have decided to accept the proposal of the Engineer - in - Chief (Buildings), Chief Engineer (Buildings), Chennai Region, and Chief Engineer (General), Public Works Department. Accordingly, administrative sanction is accorded for Rs. 75,00,00, 000/- (Rupees Seventy Five Crores only) for the construction of the Tamil Nadu National Law School at Navalur

Kuttapattu Village, Srirangam taluk, Trichirapalli district. The details of the construction of the buildings with various blocks and its plinth area are as given in the Annexure to this order.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

“ 4202 Capital Outlay on Education, Sports, Art and culture - 01. General Education – 203. University and Higher Education – Schemes in the Twelfth Five Year Plan.-II- State Plan – JA. Buildings – 16. Major works (DPC 4202 – 01-203 JA 1605).”

5. An amount of Rs. 1,00,00,000/- is provided in BE 2012 – 2013 for meeting the initial expenditure.

6. Chief Engineer(Building), Public Works Department, Trichirapalli Region is directed to take immediate action for the construction of the Tamil Nadu National Law School at Navalur Kuttapattu Village, Srirangam taluk, Trichirapalli district. The District Collector, Trichirapalli district, who has been granted enter upon permission, to enable the transfer of 25 acres of land owned by the Tamil Nadu Agricultural University at Trichirapalli district for the purpose of establishing the said National law School in the G.O. first cited, is directed to supervise and coordinate with the Chief Engineer(Building), Public Works Department, Trichy region and to report the stages of the said construction work periodically to the Government.

7. The Engineer – in - Chief (Buildings), Public Works Department, Chennai is authorised to draw and disburse the amount. The Chief Engineer (Buildings), Public Works Department while carrying out the work shall adhere to the codal provisions.

8. This order issues with the concurrence of Finance Department Vide its U.O. No. 17146/Homell/12, dated 30.03.2012.
