#### ORDER:

The Registrar, the Tamil Nadu Dr.Ambedkar Law University, Chennai in his letter read above, has stated that due to inadequacy of funds, the expenditure for following items are needed:-

and requested the Government to sanction a sum of Rs.1,00,00,000/- (Rupees one crore only) as Grant for meeting the current expenditure.

2. The Government, after careful consideration, have decided to accept the proposal of the Registrar Tamil Nadu Dr.Ambedkar Law University. Accordingly, Government sanction a sum

of Rs. 1,00,00,000 (Rupees one crore only) towards Grant for meeting the current Expenditure to the Tamil Nadu Dr.Ambedkar Law University, Chennai.

3. The expenditure sanctioned in para 2 above shall be debited to the following head of account:-

4. The expenditure sanctioned in para 2 above shall be met from the existing Budget Provision available under the above head of account.

5. The Director of Legal Studies (i/c), Chennai is authorized to draw and disburse the amount to the Registrar, Tamil Nadu Dr.Ambedkar Law University, Chennai.
