### ORDER:-

During the budget session of the year 2013-14, it has been announced by the Hon'ble Chief Minister that the construction of own buildings will be taken up for 52 Adi Dravidar Welfare and 2 Tribal Welfare student hostels, functioning in private buildings at a cost of Rs.52.00 crores.

2. In the letter first read above, the Director of Adi Dravida Welfare had sent a proposal seeking administrative sanction for constructing 54 hostels (52 in Plain and 2 in Hill area) including 5 KiloWatt Solar Power System and 12.5% administrative charges at an estimated cost of Rs.100.00 lakhs per hostel in Plain area and Rs.113.30 lakhs per hostel in Hill area, as per Public Works Department's schedule of rates and Financial sanction to the tune of Rs.27.00 crores for the construction of 27 hostels for which sites were readily available.

3. In the Government Order second read above, the Government have accorded administrative and financial sanction for the construction of 27 hostels at a total cost of Rs.27,00,00,000/- (Rupees Twenty Seven crores only) at the rate of Rs.100.00 lakhs per hostel in the first phase.

4. The Director of Adi Dravidar Welfare, vide letter third read above, has requested the Government to accord administrative sanction for the construction of remaining 27 hostels at a total cost of Rs.27.2660 crores i.e.25 hostels in Plain area at the rate of Rs.1.00 crore per hostel and 2 hostels in Hill area at the rate of Rs.1.1330 crore per hostel.

5. The Government, after careful consideration, accord administrative sanction for the construction of 27 Adi Dravidar and Tribal Welfare student hostels annexed in the Government Order at a total cost of Rs.27,16,72,000/- (Rupees Twenty Seven crores Sixteen lakhs and Seventy Two Thousand only) i.e. 25 hostels in plain area at the rate of Rs.1.00 crore per hostel and 2 hostels in hilly area at the rate of Rs.1.0836 crore per hostel by obtaining loan assistance from NABARD.
